


Tender Notice







Terms & Conditions

01. The total cost of the Shoe Materials to be purchased is Rs.3,00,000/- (including VAT and Transportation).
02. The selection of Bidder to supply the items is the sole discretion of the purchase committee. The Sample/ Catalogue produced by the bidder at the time of opening of bid shall be examined by the committee at first and the rate of the item shall be consider from the selected items only.
03. The bidders have to remain present during opening of tender with sample.
04. The bidder have to deposit security amount of Rs.3,000/- (Rupees three thousand) only in shape of NSC/Term deposit duly pledged in favour of Collector, Balangir while filling bid form. Bid filled without deposit EMD amount and tender paper cost shall be rejected.
05. The payment of bills shall be made by the Collector, Balangir as per the approved rate incorporated in the agreement and is subject to availability of allotment.
06. The supply of items to be executed within 15 days of receipt of order. In case the suppliers fail to supply required items within the specified or fail to adhere to the terms and condition or the supplied articles found billow the standard approved by the purchase committee the contract shall be terminated and the EMD/security deposit shall be forfeited.
07. In case of any complain regarding the supplied items, decision of District Collector shall binding and final who shall obtain a report from the recipient that the suppliers shall replace the same at his own cost.
08. The suppliers shall be responsible for any loss/damage during transportation to delivery point.
09. Collector, Balangir reserves the right to reject any or all the bid received without assigning any reason thereof.
10. No request for enhancement of approved rate shall be entertained.
11. Collector, Balangir may at any point of time terminate the contract for violation term and condition of agreement without notice or any of document, the suppliers has produced is found to be forged/fabricated/ unauthentic at later stage.
12. The order is liable to be cancelled at any time by providing 15 days notice in case of any problems arises.
13. The decision of the purchase committee is binding and final in selection of articles/ brand.
14. The order will be placed as per the brand and rate quoted by the bidders and also availability of funds.
