- Each tenderer should submit through **registered post/speed post (Not through private courier)**, the cost of tender paper (**non Refundable**) and the respective E.M.D (**Refundable**), in shape of NSC, KVP, POTD, BANK DRAFT and FD of Bank pledged in favour of the **Executive officer , Balangir Municipality**, is to be scanned and uploaded to the portal by the bidder. The **Balangir Municipality** will not be responsible for any **untimely delivery & non -delivery** of the registered post / speed post.
- All the relevant document as per DTCN should reach to the office of the undersigned on the time specified.
- In case of non receipt of the **original financial instruments (Cost of Tender Paper and E.M.D)** of any Bidder, the bid shall be **summarily rejected**, during on-line Technical Bid Evaluation.
- The bidder **claiming any sort of price preference or E.M.D Exemption** etc. against the **Engineer Contractor License , Scheduled caste/ Schedule tribe / Handicapped** contractor license should invariably produce the **original contractor license in person** for verification & entry as the case may be before the scheduled opening of the respective bids , else their bids shall be **summarily rejected** during on-line **Technical Bid Evaluation**.
- Rate quoted by the contractor shall be excluding GST. The GST as applicable for the work contract shall be payable to the contractor on each bill amount on production of tax invoice. The prevailing rate of GST on the gross amount on bill will be deducted from the contractor bill as tax deduction at source (TDS) as per rule.
- Additional Performance Security shall be obtained from the bidder when the bid amount is less than estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price/ rates than the estimated cost put to tender shall have to furnish the exact amount of differential cost i.e. estimated cost put to tender minus the quoted amount as Additional Performance Security (APS) in shape of Demand Draft/ Term Deposit Receipt pledged in favour of the Executive Officer within seven days, otherwise the bid shall be cancelled and the security deposit shall be forfeited. Further; proceeding for blacklisting shall be initiated against bidder as per Works Department Office Memorandum No.14299 dt.03.10.2017.
- Rates quoted more than 14.99% less than the amount put to tender will liable for rejection.
- Further corrigendum regarding any changes, will be published in the web site **www.tendersorissa.gov.in** without publication in the news papers.
- The authority reserve the right to cancel any or all tenders without assigning any reason thereof.
