



Sealed tenders are invited from the intending reputed and registered manufacturing companies / suppliers / authorized dealers having valid license or EPM rate contract for supply of Mahindra Bolero Pick-up CBC 2WD BS3 (1 no.) to be used for Aahaar Kendra, Patnagarh in Balangir district. In case of the manufacturing company in the tender process, the tender of the authorized dealers of that company shall be ignored. However after finalization of the contract, the manufacturing company may engage any or some of its authorized dealers having VAT registration / TIN No. to supply the vehicle at the approved rates at Aahaar Programme at Balangir in Balangir district.
2. Tender papers for Mahindra Bolero Pick-up CBC 2WD BS3 should be super scribed with the name of the item for which tender is filed.

2. Name of the brand should be mentioned in the quotation clearly along with ISI registration number with company list.
3. The successful quotationers should supply the vehicle within 7 days for Mahindra Bolero Pick-up CBC 2WD BS3, from the date of placing of the indent by concerned office. If the quotationer fails to supply the correct and complete indented materials within specified date mentioned in the indent, supply order would stand automatically.
4. The suppliers have to deposit EMD @ 2% of total cost of materials towards security deposit in shape of NSC/KVP/ Term Deposited Receipt.
5. The sealed papers should accompanied the self attested of the following documents:
 - i. PAN Card
 - ii. Income Tax Clearance(up to 31.03.2018)
 - iii. Dealer Registration Certificate and TIN No.
 - iv. Sales Tax / VAT clearance certificate(up to 31.03.2018)
 - v. Dealership authorization from manufacturer.
 - vi. Any other relevant document lawfully required by committee.
6. The tender received beyond the stipulated date and time without all required documents shall be liable for rejection and will not be considered. The Chairman, DAS, Balangir & Collector, Balangir will not responsible for postal or any other delay for receiving tender papers.
