





The Tender paper should reach at the District Sports Office, Balangir on or before 11.02.2019 by Registered Post/Speed Post and the same will be opened on dt. 11.02.19 at 4.00 PM in the Office of the Additional District Magistrate, Balangir in the presence of parties or their authorized representatives. The undersigned authority reserves the right to reject/cancel the tender without assigning any reason thereof.

Terms & Conditions

1. The total cost of the Dress Materials and Shoe Materials to be purchased is Rs.5,01,000/- (Rupees Five Lakhs and One Thousand) only (Including All Taxes and Transportation).
2. The selection of Bidder to supply the items is the sole discretion of the purchase Committee. The Sample/Catalogue produced by the Bidder at the time of opening of Bid shall be examined by the Committee at first and the rate of the items shall be considered from the selected items only.
3. The Bidder has to be present during the opening of the tender with samples.
4. The Bidder has to deposit security amount of Rs. 1,000/- (Rupees One Thousand) only in shape of NSC/Term Deposit duly pledged in favour of Collector, Balangir while filing bid form. Bid filled without deposit the EMD amount and Tender paper cost shall be rejected.
5. The payment of Bills shall be made by the Collector, Balangir as per the approved rate incorporated in the agreement and is subject to availability of funds.
6. The supply of items to be executed with in 15 days of receipt of order. In case the suppliers fail to supply required items with in the specified period or fail to adhere to the terms and conditions or the supplied articles found below the standard approved by the purchase Committee, the contract shall be terminated and the EMD/security deposit shall be forfeited.
7. In case of any complaint regarding the supplied items, decision of the District Collector shall be binding and final, who shall obtain a report from the recipient that the suppliers shall replace the same at his own cost.
8. The suppliers shall be responsible for any loss/damage caused during transportation to delivery point.
9. Collector, Balangir reserves the right to reject any or all the bid received without assigning any reason thereof.
10. No request for enhancement of of approved rate shall be entertained.
11. Collector, Balangir may at any point of time terminate the contract for violation of terms & conditions of agreement without notice or any of the documents produced by the supplier if found to be forged/fabricated/unauthentic at later stage.
12. The order is liable to cancelled at any time by providing 15 days notice in case of any problem arises.
13. The decision of the purchase committee is binding and final in selection of articles/Brand.
14. The order will be places as per the Brand and rate quoted by the Bidders and also availability of funds.
