

**SPECIFICATION /TECHNICAL AND FINANCIAL BID & GENERAL TERMS AND
CONDITION FOR WALL PAINTING AT G.P. LEVEL ON DIFFERENT THEMES
UNDER I.C.D.S.**

- 1) The specification of the wall paintings & the numbers are as per Annexure III.
- 2) The bidders should submit bids in two envelopes, one containing **technical bid** consisting of all technical details and the other containing the **financial bid** indicating the unit cost. The envelopes should be superscribed accordingly. Both the covers should be placed in a big sealed cover super scribing "**Tender for wall paintings.**"

2a) TECHNICAL BID

The Technical bid should contain the following

- i) Money receipt issued to the bidder towards tender cost of Rs.2000/- shall be enclosed with the tender paper. In case the tender paper is downloaded from internet, the bidder must enclose one demand draft of Rs.2000/- issued in favor of DSWO, Balangir payable at Balangir with the tender paper towards tender cost.
- ii) Past performance, if any.
- iii) A demand draft/TDR of Rs.55,000/- (Fifty five thousand) only as EMD from any nationalized Bank payable at Balangir drawn/pledged in favour of the District Social Welfare Officer, Balangir which shall be converted to bid security of the successful bidder..
- iv) Self attested copies of GST registration certificate along with Tax clearance certificate upto 31-3-2018 must be enclosed with the tender documents.
- v) Self attested Copy of the PAN card.
- vi) An affidavit undertaking that the firm is not black listed by any authority.
- vii) All pages of the tender papers signed in each pages.

2b) FINANCIAL BID

The financial bids of those bidders shall be opened those who qualify the technical bid.

The financial bid should contain the Unit price per painting inclusive of all taxes and other charges in the prescribed format in annexure-IV of the tender paper in a separate sealed envelope. The envelope must be super scribed "**Financial Bid**".

The Financial bid should be filled in properly and legible without any correction/over writing. The rate per painting should be written both in words and figures. The rate quoted should be final and the tenderer shall not be allowed to change the same under any circumstances.

OTHER TERMS AND CONDITION:

- 3 Conditional tenders shall not be entertained and shall be rejected forthwith.
- 4 EMD of **Rs.55,000/-** in the form of demand draft drawn in favour of DSWO, Balangir or fixed deposit certificate of the identical amount pledged in favour of DSWO, Balangir must be enclosed along with the tender papers. EMD of the successful bidder shall be kept as bid security. The same shall only be released on successful completion of the work as per the finance department circular No. 4939 dt. 13-2-2012. No interest shall be paid in time of release of the bid security.
- 5 The prototypes of the paintings are at **Annexure-V(1) to Annexure-V(4)** and in no circumstance these paintings shall be re-designed or modified.
- 6 The agency finalized for work shall be provided with the list of places where the wall paintings shall be done by the concerned CDPOs. CDPOs shall identify four such locations per GP in consultation with the representatives and supervisors where the paintings shall be done.
- 7 - No advance amount shall be paid to the agency/ firm. The work to be completed at its own cost by the awarded firm. Payment shall be made only after successful completion of the work on receipt of certificate of completion from the concerned CDPOs.
- 8 Request for rise in the unit cost shall not be entertained.
- 9 Payment shall be made by e-transfer of funds to the account of the firm on submission of completion certificate duly countersigned and certified the concerned CDPOs. As such, the CDPOs concerned must visit the painting sites before issuing the certificate of completion.
- 10 The work must be completed with one month from the date of issue of indent order.
- 11 The Authority reserves the right to reject any or all tenders without assigning any reason *thereof*.
