Conditions:

1. Each NGO is to sign a memorandum of understanding (MoU) within 07 days from the issue of works order.

2. After signing of MoU the District Administration will release 20% of the total amount allotted finalized against the NGOs @ Rs. 3000/- per village.
 3. After signing of MoU the NGO is to implement the programme in coordination with District authority, respective Block administration and Gram Panchayats.
 4. The NGOs to complete the works as defined with 06 months from the date of signing of MoU.
 5. The remaining 80% of the agreed amount to be released, as per schedule for completion of the VDMP process in the allotted villages and submission of VDMPs duly signed by Local Sarpanch.
 6. The NGOs should furnish their e-mail id & contact number for communication of Guidelines for preparation of VDMPs at the time of signing of MoU.
- The District Level Monitoring Committee will review the progress of VDMP from time to time at regular interval.






