

If the quotationer fails to supply the correct and complete indented materials within specified date mentioned in the indent, supply order would cancel automatically.
4. The suppliers have to deposit EMD @ 2% of total cost of materials towards security deposit in shape of NSC/KVP/ Term Deposited Receipt.
5. The sealed papers should accompanied the self attested of the following documents:
