The Deputy Director, Geology, GWD Division, Bolangir on behalf of Government of Odisha invites percentage rate of bids for the works detailed in the table below from the contractors registered with state Govt. and contractors of equivalent grade/ class registered with Central Government/ Railway/ M.E.S. for execution of works to be eventually drawn up in the item rate contract form. The Bidders registered under other Sate Govt. / MES/ Railway/ CPWD in equivalent rank may participate in the tender work in the state. But the successful bidder must have the registration under the Sate PWD or Govt. Engineering department before signing of the agreement. The bidders should have CDMS (Contractor Database Management System) 7 digit unique code. The bidders may submit bids for the below work.

Division, Bolangir during office hour i.e. 10 AM to 5.30 PM of all working days till last date of sale of tender papers.

Bids must be accompanied by EMD of the amount specified for the work in the column-5 of table above should be drawn in favour of Deputy Director, Geology, GWD Division, Bolangir and payable at Bolangir. Bidders claiming exemption of EMD, ISD price preference, other facilities and concession etc have to produce necessary documentary evidences in support of their claim at the time of submission of tender. Bidders should submit their tender documents through postal speed post or registry post only. No courier service is allowed. The undersigned will not be held responsible for the postal delay if any.
3. The sale of the bid document from dt.25/11/2019 to 2/12/2019 during 10 AM to 5.30 PM on all working days and sealed bids shall be received up to 5.30 PM on 2/12/2019. The bids shall be opened on dt. 3/12/2019 at 12.30 PM in the office of the undersigned in the presence of the bidders/ their representatives if any. If the office happens to be closed for any reason thereof on the date of receipt and opening of the bids shall be received on the next working day at the same time and venue.
4. Additional performances security shall be deposited by the bidder when the bid amount is less than the estimated cost put to tender. In such event the bidders who have quoted less bid price/

rate than the estimated cost put to tender shall have to furnished the exact amount of differential cost i.e. estimated cost put to tender minus the quoted amount as additional performance security in shape of NSC/ Post office saving account/ post office term deposit account/ KVP/ term deposit from any nationalized bank duly pledged in favour of Deputy Director, Geology, GWD Division, Bolangir and payable at Bolangir along with the bid at the time of submission of bids. Bid submitted without deposit of required additional performance security is liable for rejection.

5. An affidavit shall be furnished by the bidder along with the tender paper about the authentication of tender documents including bid security. A declaration will be made in the affidavit that the bidder has not been blacklisted by the competent authority and his license is valid. Bid submitted without deposit of affidavit liable for rejection.
6. Other details as specified in the bidding documents and can be obtained from the Assistant Engineer (Civil) of this office. The authority reserves right to reject/ cancel any or all the tenders without assigning any reason thereof.
