- 2- The Tender must be handed over by the bidder and shall be accompanied with copy of Voter Card/ Aadhar Card/ PAN Card and a Bank Draft of Rs 1,000/- (as EMD) for each vehicles in favour of BDO, Belpada which shall be subjected to refund immediately after tender process is over except in case of highest bid amount accepted by the competent authority.
- 3- The successful bidder has to pay GST amount as applicable over and above bid amount.
