Sealed Quotation/tenders are invited from interested reputed Travel Agencies/Tour Operators or private vehicle owner having valid GST registration (Copy of supporting document to be enclosed) and GeM registration for providing 01(one) Nos of diesel/Petrol driven TUV300/BOLERO/SUMO GOLD/ ERTIGA vehicle, which shall confirm to the following terms and condition for Officials use in Block Office, Puintala (Balangir) on monthly rent basis for the financial year 2020-21.

The undersigned reserves the right to reject all or any of the quotation without assigning any reason thereof.

TERM AND CONDITION

The vehicle must be in road worthy condition, shall not be more than 3years old from the date of initial registration and must have valid Registration Certificate, Fitness Certificate, Valid contract carriage permit, proof of up to date tax payment etc. Which are mandatory for plying of vehicle (Copy of supporting document to be enclosed).

- 1) The Driver of the vehicle must have a valid Driving License for driving transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle (Copy of supporting document to be enclosed).
- 2) The Driver should be well behaved, gentle and obedient in nature. It shall be the responsibility of the bidder to provide a good driver and the salary of the driver shall be borne by the owner.
- 3) All the expenditure of the vehicle towards repair, replacement of spare parts, lubricating oil of engine, Gear box and different coolant, tires, tubes and battery etc. Will be borne by the bidder. In case of breakdown for reasons whatsoever the replacement of a vehicle of the same or better model shall be provided by the owner of the vehicle/ bidder. Priority will be given to the higher version of vehicle.
- 4) A sum of 5000/- in shape of STDR shall be pledged in favour of the BDO, Puintala and the same is to be submitted along with the tender/quotation as security deposit. After completion of tender process, same will be refunded to unsuccessful bidders.
- 5) The vehicles shall report for duty for minimum of 25 days in a month. The hired vehicle cannot be used for any private/ commercial purpose beyond office hours or during holidays.
- 6) The monthly rate of hire charges be quoted separately in the general bid information (excluding fuel and lubricants) and bid should not existing Rs.31000/-.
- 7) The vehicle must achieve a fuel efficiency of 10KMs per litre.
- 8) The details of the make and year of manufacture of the vehicle, Registration No, Mileage (KMs covered per litre) and name of the driver with driving license No. And period of validity should be specifically provided in the general bid information to be furnished with the Quotation/ Tender. - 9) If the services are found to be unsatisfactory, client shall give one month notice and terminate the agreement. In case the service provider intends to withdrawal the services of his vehicle and terminate the agreement, it shall be mandatory upon him to grant one month notice before such withdrawal of service and termination of agreement. If the bidder violates any of the terms of contract, Government shall forfeit the entire amount of security deposit.
- 10) The Quotation completed in all respect should reach to the undersigned on or before 11.05.2020 01: 00pm & shall be opened on the same day at ___pm in presence of the bidders or their authorized representatives.
