
Sealed Tenders on plain papers or letter paid is invited by the undersigned for disposal of the Government vehicle ORR-9466 of ICDS Project, O/o CDPO, Titilagarh laying in the office garage of ICDS Titilagarh.

2. The envelop carrying the bidding paper must be scribed in capital letter with  
"EXPRESSION OF INTEREST FOR AUCTION SALE OF VEHICLE"
3. The indenting bidder(s) may inspect the vehicle parked in the aforementioned place during office hour on any working day before or after submitting the bidding documents.
4. Each bidding document must be accompanied with Earnest Money deposit of Rs 1000/-) Rupees One thousand) only in shape of demand draft drawn in favour of CDPO, Titilagarh which will be refunds after the finalization of the bid except in the case of successful bidder
5. The upset price for the vehicle is fixed at Rs 26,000/- (Rupees Twenty-six thousand) only
6. The eligible bidder quoting the highest price shall to deposit 25% of the offered price immediately on the spot & rest must be deposited with in seven days of the deposit of initial amount. Earnest money deposited by the successful bidder shall be adjusted at the time of final payment of the bidding cost by the successful bidder.
7. VAT as admissible shall be paid on the bidding cost by the successful bidder.
8. The sealed biding document should reach the undersigned on or before 10.08.2020 up to 5.30 PM during office hour by registered post/speed post or by hand at the latest and the bid shall be opened date-14.08.2020 11.00 AM by the Auction Sale Committee in the office chamber of CDPO, Titilagarh and the bidders are at liberty to be present or represented by their authorized representatives during opening of the bid. If the last date of receipt of bidding document or the date of opening is declared later as a Government holiday, the process of receiving and opening of bid shall be nest working day without any alteration of timings. Bidding documents received or handed over beyond the date and time fixed shall not be entertained and the undersigned shall not be responsible for late submission/receipt of bidding documents.
9. The successful bidder should remove the vehicle within seven days from the date of final payment and collect the documents of the vehicle from the office of CDPO, Titilagarh.

On failure to remove the vehicle from the campus, ground rent at the rate of 1% of the bidding value for each day or part of the day shall be charged till its removal from the campus. If the ground rent so charged exceeds the sale value deposited, then the bidder shall cease to have any right the vehicle and the amount so deposited shall be adjusted towards ground rent. Tolls implements of spare parts shall not be delivered with the vehicle.

10. Authority reserves the right to reject any or the entire bid papers without assigning any reason thereof.






