

1. The bidders are to submit the bid in online mode with the requisite cost of tender paper (non Refundable) and the respective E.M.D (Refundable), are to be deposited in online mode. The Balangir Municipality will not be responsible for any mishaps.
2. All the relevant document as per DTCN should be uploaded in the portal at correct places.
3. The bidder claiming any sorts of price preference or E.M.D Exemption etc. against the Engineer Contractor License, Scheduled caste/ Schedule tribe / Handicapped contractor license should invariably produce the original contractor license in person for verification & entry as the case may be after the scheduled opening of the respective bids, prior to signing the agreement.
4. Rate quoted by the contractor shall be excluding the GST. The GST as applicable for the work contract shall be payable to the contractor on each bill amount on production of tax invoice. The prevailing rate of GST on the gross amount on bill will be deducted from the contractor bill as tax deduction at source (TDS) as per rule.
5. Additional Performance Security shall be obtained from the bidder when the bid amount is less than estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price/ rates than the estimated cost put to tender shall have to furnish the exact amount of differential cost i.e. estimated cost put to tender minus the quoted amount as Additional Performance Security (APS) in shape of Demand Draft/ Term Deposit Receipt pledged in favour of the Executive Officer, Balangir Municipality within 7(seven) days, otherwise the bid shall be cancelled and the security deposit shall be forfeited. Further, proceeding for blacklisting shall be initiated against the bidder as per Works Department Office Memorandum No.14299 dtd.03.10.2017.
6. Rates quoted more than 14.99% less than the amount put to tender will liable for rejection.
7. Date of the Lucky draw is scheduled to be held on Dtd.19.10.2020 at 11.30 AM. & no intimation in letter / over phone will be communicated. Bidders are requested to attend the lucky draw on the mentioned date at the office of the undersigned.
8. Work completion time will be followed strictly so bidders should submit work programme during the time of agreement.
9. Further corrigendum regarding any changes, will be published in the web site www.tendersorissa.gov.in without publication in the news papers. Hence bidders are advised to visit the website regularly to know the updates/status.
10. The authority reserve the right to cancel any or all tenders without assigning any reason thereof.


