Sealed tenders are invited in double covers system by District Rural Development Agency, Balangir from Intended reputed & registered Suppliers/ firms / agencies with the following terms & condition for supply of PMAY(G)-BPGY Logo tiles (15 x 15 Inch with 6 mm thickness) Biju Pucca Ghar and delivery all at 14 (fourteen) Blocks point of Balangir District as per design types & specification given by this Office.

The tender/ bid documents completed in all respect should reach the undersigned on or before **28.12.2020** latest by 5.00 PM by **registered post/speed post/Courier service** only. The tenders will be opened on dt.29/12/2020 at 4.00 PM in the presence of the committee member and bidders or their authorized representatives in the Conference hall of DRDA, Balangir.

The tender shall be submitted in a sealed envelope/cover **super scribed with "Supply of PMAY(G)-BPGY Logo tiles under PMAY(G)-Biju Pucca Ghar Yojana "** to **D.R.D.A., Balangir.**

The request for proposal/ bid document format along with terms & condition, detail specification of PMAY(G)-BPGY Logo tiles and Eligibility criteria can be viewed/ downloaded from the district website <http://balangir.nic.in> Non-Refundable Demand Draft of **Rs. 10000/-**(Rupees Ten Thousand) only in favour of Project Director, DRDA, Balangir shall be deposited along with the Bid Document towards Tender Paper Cost otherwise the bid will be rejected.

Terms & Conditions

1. The bidders must be a registered firm/ Agency.
2. The bidder must have similar work experience. Copy of work order clearly specifying the works & performance certificate (submit necessary documents with photo copy details).
3. The bidder can submit only one Bid. Multiple Bids submitted by any bidder shall result in rejection of all his/her bids.
4. The bidder must have been registered under Goods & Services Tax (GST) Act and must have a valid GSTIN number. The bidder must have a valid PAN/ TAN number.

5. The bidder must have minimum average turnover of Rs.1.00 crore for the last 3 (three) financial years. Copy of Income Tax Return of the firm for corresponding financial year/ copy of the Audited Financial Statement of last three financial years duly audited by Chartered Accountant should be attached with the application.
6. The tender shall remain valid for a period not less than One Year after the deadline date specified for submission.
7. The quotation shall be submitted in a sealed envelope/ cover and **Superscribed with "Supply of PMAY(G)-BPGY Logo tiles under PMAY(G)-Biju Pucca ghar Yojana to DRDA, Balangir.**
8. The bidder / representative of the bidder must submit a sample PMAY(G)-BPGY logo tile as per specification during the opening of the tender document.
9. The rate quoted should be inclusive of all taxes and other dues like transportation cost up to the delivery point i.e. all 14 Block Headquarters of Balangir District.
10. The quotation duly filled in with all required documents should reach the Office of The Project director, DRDA, Balangir latest **by 5.00 PM on 28.12.2020**. The sealed tender received within the deadline will be opened on **29.12.2020 at 4.00 PM** in the Conference Hall of DRDA, Balangir in the presence of the committee member and bidders or their authorized representatives.
11. EMD of **Rs.2,00,000/-** (Rupees Two lakh) only shall be deposited by the intending bidders in shape of DCR/TDR/NSC (not less than 6 months) **in favor of the Project Director, DRDA, Balangir** and submitted along with the tender.
12. The selected firm has to deposit performance security of **5%** of the successful bid amount shall be deposited by the bidder only in shape of DCR/TDR/NSC issued by any scheduled commercial Bank pledged **in favour of the Project Director, DRDA, Balangir**, which will be refunded to the vendor after successful completion of the work.
13. The 2nd lowest bidder will be offered to supply the material at the approved quoted price of the L₁ bidder if the 1st lowest bidder fails to supply and this will be followed by forfeiting of EMD of the 1st lowest bidder.
14. The selected bidder has to supply of the items within 45 days from the date of issuance work order.
15. The purchaser will examine, evaluate and compare the quotations received from the responsive Bidders and select the L1 bidder taking in to consideration the lowest price quoted for all items taken together.
16. The bidder whose bid is accepted will be notified of the award of contract by the purchaser prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the purchase order.



17. Bidders are required to quote their price (in Rs.) against the name of the items, specification & quantity in **Annexure-B** for supply of Logo tiles under PMAY(G)-BPGY and submit the same in a separate sealed cover/ envelope. Both the envelope (Technical Bid and Financial Bid) should be in another envelop **superscribed with "Supply of PMAY(G)-BPGY Logo tiles under PMAY(G)-Biju Pucca Ghar Yojana "** to D.R.D.A., Balangir.
18. If the Technical Bid is found complete and responsive, the financial bid will be opened.

Bid Price Condition:

- The total price shall be inclusive of all taxes, transportation and other expenses.
- The Rates quoted by the bidder shall be fixed for the duration of the contract and shall not be subject to adjustment on any account.

Payment Condition:

- Payment shall be made after and on receipt of necessary certificate from concerned Block Development Officer and if found satisfactory.
- If the successful bidder delays beyond the stipulated periods as specified on the terms and condition, he may be charged penalty/deduction @1% at the time of payment.

20. The supplier should submit the Bank account details for transfer of funds.
21. Any effort by a bidder to influence the purchaser in its decision on bid evaluation or placement of purchase order may result in rejection of the bidder's offer.
22. Notwithstanding the above, the Authority reserves the right to accept or reject any or all bids at any time prior to the issue of contract letter without assigning any reason thereof.


