### List of Documents to be submitted:

1. Self certificate stating that the agency has not been black listed in the past.
2. Average annual turnover of 3 consecutive years must be 7 lakhs or above. (Turnover statement of the last 3 years certified by chartered accountant has to be furnished)
3. Applicant agency must furnish a copy of their GSTIN registration certificate and clearance up to February'2021.
4. Agency must have experience in conducting WALL PAINTING.
5. The agency must have been empanelled under different Government organisation within the district.
6. The Authority reserves the right to accept or reject any or all quotation without assigning reasons thereof. Application received after due date taken as rejection.
7. The contract for providing the services is likely to commence from the date to be specified and would continue for a period of one year. The period of contract may further be extended for two years on yearly basis depending on satisfactory performance of the Agency.

The agreement shall commence from the date of signing and shall continue initially for a period of one year unless it is terminated by the authority owing to deficiency of service, substandard quality of performance, change in specification and requirement.
