
### SHORT TENDER CALL NOTICE

EMD @1% of the gross work value calculated on bidding rates is to be submitted infavour of Executive officer, Balangir Municipality in shape of D.D/T.D.R/ after receipt of letter of acceptance. Tenderer are requested to submit their sealed envelope with requisite documents through Speed post/Register Post/in the drop box in person at the office of the undersigned.

Opening of bids will be held on 01.06.2021 at 12.00 Noon, in the Council Hall of Balangir Municipality in presence of the tender committee and the bidder or their authorised representative. The tenderer should submit the attested copy of valid GSTN clearance certificate, income tax clearance certificate and PAN Card along with the tender paper. The rate should be inclusive the cost of maintenance, salary of drivers and all other related expenditure inclusive of taxes, only the fuel charge will be born by the ULB. The successful bidder shall supply the vehicles to be hired from Dt.02/06/2021 to the office of the undersigned.
