

**TERMS AND CONDITIONS**

1. The sealed bid documents in closed cover super scribed by "AUCTION FOR 108 AMBULANCE" should reach the office of the Chief District Medical & Public Health Officer, Balangir on or before 22.07.2021 till 2.00 p.m during the working hours. The bid documents received within the stipulated date & time will be opened on 22.07.2021 at 5.00 p.m in the office chamber of the CDM & PHO, Balangir in the presence of Purchase Committee members and the bidders/their authorized representative.
2. The Ambulance put to auction will be disposed of on "**AS IS WHERE IS BASIS** along with **outstanding Road Tax Liability if any**" to be paid by the approved bidder. No pending Road Tax if any will be bear by this office.
3. Separate bid documents should be submitted for each vehicle.
4. The intending bidder may inspect the vehicles during office hours.
5. Intending bidders shall have to enclose bank drafts/Banker's cheque of **Rs5000/-(Rupees five thousand)** only drawn on any Nationalized Bank in favour of "**CDM & PHO, Balangir**" payable at Balangir. Separate EMD to be submitted for each vehicle to auctioned. Any bid document submitted without EMD will be summarily rejected.
6. The EMD of unsuccessful bidders will be refunded as it is in the same day opening bid.
7. The bidder quoting highest price shall have to deposit 25% of the approved auction price in the same day on approval of the bid and the rest amount to be submitted within 07(Seven)days of issue of the confirmation letter. In case of failure to pay the rest 75% of the approved auction price within 7 days, the deposit including EMD will be forfeited and the vehicle will be put to fresh auction.
8. The Ambulances will be handed over to the successful bidders after making the full payment of the approved auction price.
9. The approved bidder will have to remove the vehicle from the site within 07 (seven) days of payment of auction money in full. The safeguard and custody of the vehicle shall be the responsibility of the bidder. No claim or compensation in this regard shall be entertained by the CDM & PHO, Balangir.
10. Ground charge @ 1% of approved bid will be charged for each day or part of the day from the successful bidder till the vehicle is removed from the site in case of failure to remove the same within the stipulated time period.
11. Where the ground charge exceeds the sale price deposited, the bidder shall cease to have any right on the vehicle. The amount deposited by the tender will be adjusted towards the ground charge and the vehicle become absolute property of CDM & PHO, Balangir free from encumbrances and disposed of by fresh tender.
12. In case of non finalization of auction by the CDM & PHO, Balangir, the EMD deposited by the bidders will be refunded without any interest and acceptance of the particular auction will be null and void.
13. The undersigned reserves the right to accept/ reject any or all bid without assigning any reason thereof.
