
QUOTATION CALL NOTICE





- 1 The documents for quotation will be available from the office of the undersigned from 10.00 A.M of 09.07.2021 up to 5.00 P.M. of 16.07.2021.
- 2 The sealed quotation should reach to the office of the undersigned before 1.00 PM of dt.19.07.2021 and will be opened at 4.00 P.M. of 19.07.2021, in the office chamber of the Executive Officer, Balangir Municipality in presence of the intending bidders or their authorized representatives. If the office happens to be closed on the date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.
- 3 Cost of tender paper amounting to Rs. 2,000/- (Rupees Two thousand) only, (non-refundable) in shape of cash will be paid in the office of the undersigned during purchase of the documents and the MR copy also to be submitted as token of proof.
- 4 If the quotation will be downloaded from the website then the Cost of tender paper amounting to Rs. 2,000/- (Rupees Two thousand) only, (non-refundable) in shape of D.D drawn in favour of Executive Officer, Balangir Municipality will be submitted along with the bid document.
- 5 The quotation should accompany with Bid declaration form duly signed by the bidder. After award of the quotation the bid security @ 2% of the approved amount is to be pledge in favour of the Executive Officer, Balangir Minicipality, and the bid security will be retain with the undersigned till the closure of the agreement.
- 6 The quotation should accompany with copies of valid Dealership certificate, GST clearance certificate & PAN compulsory with the quotation paper. Otherwise the quotation will be rejected.
- 7 The copy of Factory Price should be accompany the quotation.
- 8 All quotations received will remain valid for a period of 3 months from the date of receipt and validity of tender can also be extended if agreed to by the tenderer and the Department.
- 9 The rates should be quoted both in words and figures. In case of discrepancy in rate between words and figures, amount in words will prevail.
- 10 Completion time for the items to be installed are 30days. After due commissioning of the CCTV system running with all arrangement successfully and after signing the commissioning certificate from the authority, the period of AMC will be started. The rate quoted in this quootatoion for AMC will valid for 3 consecutive years. In this period no enhancement in the AMC charges will be made. The AMC period may be extended depending upon the requirements and due approval from the competant authority.
- 11 After award of the quotation the agency will execute an agreement with the undersigned., he terms and conditions of the agreement will be laid by the undersigned as per the requirement.
- 12 Payment clause will be fixed during signing of the agreement.
- 13 Under no circumstances interest is chargeable for the dues or additional if any pending for payable for the work.
- 14 The warrenty period of the item under description will be as per the company's description.
- 15 On no account the Contractor should sublet the work, or any portion of the work to any body.
- 16 Authority reserves the right to allot the work in batches amongst different tenderers, if necessary for speed execution of work and the contractor is not entitled to have complain on this account.
