Sealed quotations are invited from interested reputed Travel Agencies/Tour Operators or private individuals for providing 1(one) no of Non- AC diesel driven vehicles(as per annexure II) i.e. TUV300/Bolero/Sumo Gold/Ertiga for official use in the office of the ARCS, Balangir Circle, Balangir on monthly rent basis.

The vehicle must be Road worthy conditions, shall not be more than 3 years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, valid contract carriage permit, proof of up to date tax payment etc. which are mandatory for paying of vehicle.

- 1) The driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
- 2) The Driver should be well behaved, gentle and obedient in nature.
- 3) A sum of Rs.5000/- shall be deposited by the intending bidders in shape of account payee bank draft drawn in favour of the Assistant Registrar of Coop. Societies, Balangir Circle, Balangir and submitted along with the tender as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
- 4) The monthly rate of hired charge be quoted separately in the general bid information(excluding fuel and lubricants)
- 5) The vehicle must achieve a fuel efficiency of at least 10 KM per litre.
