- The tenderer is to be submitted in sealed cover containing EMD Certificate, Tender paper cost on DD(non Refundable) in favour of the Executive officer, NAC TUSURA, Xerox Copy Of Contractors Registration certificate, PAN card, valid GST clearance certificate, GSTN, Original affidavit regarding authenticity of document & No-relationship certificate as per the relevant clauses of this DTCN and special conditions if any. Must be delivered positively in the tender box /by registered post / by speed post / having mentioned as Tender Call Notice No. TSR-NAC-05/2021-22 in the office of the Executive Officer, NAC Tusura. And also All documents is to be scanned and uploaded to the portal by the bidder
- The bidders are to submit the bid in online mode with the requisite cost of tender paper (non Refundable). The respective E.M.D are not required as per the notification No.7963/HUD-BUD-01/2021 Dtd.12.04.2021 during submission of bids. However the same is to be produced by the successful bidder after award of the contract.
- Bids must be delivered positively in the tender box/by registered post / by speed post / having mentioned as Tender Call Notice No. TSR-NAC-05/2021-22 in the office of the Executive Officer, NAC Tusura, the cost of tender paper (non Refundable), in shape of DD in favour of the Executive officer, NAC TUSURA, is to be scanned and uploaded to the portal by the bidder.
- All the relevant document as per-DTCN should reach to the office of the undersigned on the time specified.

5. In case of non receipt of the original financial instruments (Cost of Tender Paper and E.M.D Cost Certificate) of any Bidder, the bid shall be summarily rejected, during on-line Technical Bid Evaluation.
6. The bidder claiming any sort of price preference or E.M.D Exemption etc. against the Engineer Contractor License, Scheduled caste/ Schedule tribe / Handicapped contractor license should invariably produce the original contractor license person for verification & entry as the case may be before the scheduled opening of the respective bids on OffLine; else their bids shall be summarily rejected during on-line Technical Bid Evaluation.
7. Rate quoted by the contractor shall be excluding the GST. The GST as applicable for the work contract shall be payable to the contractor on each bill amount on production of tax invoice. The prevailing rate of GST on the gross amount on bill will be deducted from the contractor bill as tax deduction at source (TDS) as per rule
8. Additional Performance Security shall be obtained from the bidder when the bid amount is less than estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price/ rates than the estimated cost put to tender shall have to furnish the Additional Performance Security (APS) in shape of Demand Draft/ Term Deposit Receipt pledged in favor of the Executive Officer, NAC Tusura within 7(seven) days, otherwise the bid shall be cancelled and the security deposit shall be forfeited. Further, proceeding for blacklisting shall be initiated against the bidder as per Works Department Office Memorandum No.4559 dtd.05.04.2021.

9. The bids for the works shall remain open for acceptance for a period of 90 days from the last date of receipt of bids. If any bidder / tenderers withdraws his bid / tender before the said period or makes any modification in the terms and condition of the bid, the EMD deposited at the time of submission of tender shall stand forfeited.
10. Rates quoted more than 15% less than the amount put to tender will liable for rejection.
11. The authority reserve the right to cancel any or all tenders assigning any reason thereof.
