Term and conditions

1. Quotation by the Firm / Re-Seller / Dealer / Trader / Contractors should be submitted in the office of the undersigned in a sealed cover along with sample by 5.00 P.M. of 04.02.2022 in sealed cover.
2. The selected Firm / Re-Seller / Dealer / Trader / Contractors should supply the Shoes (Power, Red Chief) shocks, Bag, Arms Badge/ Fiber Lathi and Whistle Cord in good condition within one month from the date of placing the orders.
3. Delivery of the articles should be made in the Divisional office, Bolangir Forest Division at their own cost.
4. Damaged Shoes (Power, Red Chief) shocks, Bag, Arms Badge/ Fiber Lathi and Whistle Cord should be replaced by the party at their own cost.
5. All articles should be supplied as per the sample given and selection thereof, failing which the supply orders will be cancelled automatically.
6. The rate of the articles should be quoted including all taxed.
7. Copy of GST clearance should be accompanied along with the quotation.
8. Payment will be made in shape of bank Draft/RTGS/ Account deposit through Treasury Bill after receipt of the articles as per the sample.
