

Sealed Quotations/Tenders are invited from interested reputed Travel Agencies/ Tour Operators or Private Individuals for providing 1 No. of AC diesel driven vehicle (i.e TUV 300/ SCORPIO/ ERTIGA/ CRETA) having seating capacity not more than than Seven including driver. The hire charges of the vehicle is maximum @31,000/- per month with minimum average of mileage @10 kmpl of diesel which shall confirm to the Terms and Conditions at (Annexure-II) for official use in Block office, Gudvella under Rural Housing Scheme of P.R. Deptt. on monthly rent basis.

- The vehicle must be in Road worthy condition, shall not be more than 2 years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, Valid Contract Carriage Permit, Proof of up to date tax payment etc. which are mandatory for plying vehicle.
- The Driver of the vehicle must have a valid Driving license for driving high transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
- The Driver should be well behaved. Gentle and obedient in nature.
- A sum of Rs.5000/- (Rupees Five Thousand) only shall be deposited by the intending bidders in shape of Accounts payee Bank Draft drawn in favour of BDO, Gudvella and submitted along with the tender/ quotation as security deposited. After completion of quotation process, the amount will be refunded to the unsuccessful bidders.
- The monthly rate of hire charges be quoted separately in the general bid information (excluding fuel and lubricants).
- The maximum hire charges per month is Rs.31,000/- (Rupees Thirty one thousand) only.
- The Vehicle must achieve a fuel efficiency of 10 Kms per litre.
- The details of the make and year of manufacture of the vehicle, registration no, mileage (kms covered per litre) and name of the Driver with Driving license No. and period of validity should be specifically provided in the general bid information to be furnished with the Quotation/ Tender (Annexure-III).
- The Quotation completed in all respect should reach the undersigned on or before 31-03-2022 by 11.00 A.M and shall be opened on the same day at 12 Noon in presence of the bidders or their authorized representatives.


