The **Divisional Forest Officer, Bolangir** on behalf of Governor of Odisha invites **Percentage Rate** bids in **Single Cover System** for the construction of Civil work as detailed in the table, from the class of eligible contractors as mentioned in column-7 (Seven) registered with the State Governments & Contractors of equivalent Grades/ Class Registered with Central Government/ MES/ Railways for execution of **Civil work**. The proof of registration from the appropriate authority shall be enclosed along with the Bid. If successful, the bidder who has not registered under state government has to register under the state PWD in appropriate class of eligibility before signing of the agreement.

The bidders may submit bids for the following works.

- 1) Bid documents consisting of plans, specifications, the schedule of quantities and the set of Terms & Conditions of contract & other necessary Documents can be seen in the website www.tendersodisha.gov.in.
- 2) Earnest Money Deposit/ Bid security of the amount specified for the works should be deposited through on-line mode.
- 3) The Bid documents will be available in the website <https://tendersodisha.gov.in> from **10:00 Hrs. of 01/06/2022 to 17:00 Hrs. of 09/06/2022**.
- 4) The Bidder must possess **Compatible Digital Signature Certificate (DSC) of Class II or Class III**.
- 5) Bids shall be received only "On-line" on or before **17.00 Hrs. of 09/06/2022**.
- 6) Bids received "on-line" shall be opened **at 09.30 Hrs. on 10/06/2022** in the office of the **Divisional Forest Officer, Bolangir Forest Division** in the presence of bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the stipulated date of opening of Bids as specified, the bids will be opened on the next working day at the same time and venue.
- 7) Detailed information as contained in the D.T.C.N. shall have to be strictly adhered to while submitting the tender papers.
- 8) Any tenderer desirous to avail any facility as per certain circular/order of Government have to apply for the same in writing along with the tender paper. Claim at the time of opening of tender or later will not be entertained.
- 9) Other details can be seen in the bid documents.
- 10) This notice is to be read with all the Clauses/Addendum to the "Procedure to participate in on-line bidding".
- 11) If any of the intending bidders wish to withdraw from participation in the bid, he/she can freely

Withdraw from the participation before scheduled date and time of closure, failing which action as deemed fit as per relevant Codal practice will be taken against him/her.

- 12) Any Corrigendum/Addendum will be displayed in the website www.odishaforest.in & <https://tendersodisha.gov.in> only.
- 13) The bidders have to submit the Additional Performance security amount (i.e. estimated cost minus the quoted amount) in shape of Term Deposit Receipt/ Bank Guarantee pledged in favour of the **Divisional Forest Officer, Bolangir Forest Division** from any Nationalized/ Scheduled Bank in India in original before acceptance of tender, if their quoted amount is less than the estimated cost.
- 14) If after opening of the tender it is seen that, the tender has to be decided through a transparent lottery system then the lottery date will be intimated through email, WhatsApp no. and speed post. The lottery will be held even if no bidder remains present.
- 15) Other details can be seen in the bidding documents.
- 16) The authority will not be held responsible for any technical problem / failure of Network, Server during the schedule dates of online bidding.
- 17) The authority reserves right to cancel the bid without assigning any reason thereof.
- 18) Bidders shall provide their e-mail id, correspondence address, Mobile No. (What's App) along with scan copy of valid GSTIN, PAN, Machinery documents and other documents as per DTCN Clause.
