

**I.C.D.S. PROJECT, GUDVELA**

Sealed Tenders on plain paper or letter pad is invited by the undersigned for disposal of the **Government vehicle (Jeep) No OR-03- 4266** of ICDS Project, Gudvela lying in the Office premises at Gudvela.

2. The envelop carrying the bidding paper must be super scribed in capital letter with 'EXPRESSION OF INTEREST FOR AUCTION SALE OF VEHICLE'.
3. The intending bidder(s) may inspect the vehicle parked in the aforementioned place during office hours on any working day before or after submitting the bidding documents.
4. Each bidding document must be accompanied with Earnest Money deposit of Rs.1000/- (Rupees one thousand) only in shape of demand draft drawn in favour of CDPO, ICDS Project, Gudvela which will be refunded after the finalisation of the bid except in the case of successful bidder.
5. The upset price for the vehicle is fixed at **Rs.6,000/- (Rupees Six thousand)** only.
6. The eligible bidder quoting the highest price shall have to deposit 25% of the offered price immediately on the spot and the rest amount must be deposited within seven days of the deposit of initial amount. Earnest money deposited by the successful bidder shall be adjusted at the time of final payment of the bidding value of the bidder.
7. The sealed bidding document should reach the undersigned on or **before 4.00 PM of 20-07-2022** during office hours by registered post/speed post at the latest and the bid shall be opened on 21.07.2022 at 12pm by the Auction Sale committee in the office chamber of the undersigned and the bidders are at liberty to be present or represented by their authorised representative during opening of the bid, if the last date of receipt of bidding documents or the date of opening is declared later as a Government holiday, the process of receiving and opening of bid shall be the next working day without any alteration of timings. Bidding documents received or handed over beyond the date and time fixed shall not be entertained and the undersigned shall not be responsible for late submission/receipt of bidding documents.
9. The successful bidder shall remove the vehicle within seven days from the date of final payment and collect the documents of the vehicle from the office of the undersigned. On failure to remove the vehicle from the campus, ground rent at the rate of 1% of the bidding value for each day or part of the day shall be charged till its removal from the campus. If the ground rent so charged exceeds the sale value deposited, then the bidder shall cease to have any right over the vehicle and the amount

so deposited shall be adjusted towards ground rent. Tools, implements of spare parts shall not be delivered with the vehicle.

10. The undersigned reserves the right to reject any or the entire bid papers without assigning any reasons thereof.
