

Eligibility

1. The applicant must be a citizen of India and belongs to Balangir district only.
2. The applicants must be 18 years of age as on the date of submission of the application
3. Allotment of stall shall not be made who have availed stall from ZSS Balangir / any stall by any Government body / agency/ organization in Balangir Municipality area.

Submission of application

1. The applicant has to submit the filled in form as attached in the Annexure-I duly signed along with all requisite documents in a sealed envelope super scribed "APPLICATION FOR ALLOTMENT OF ZSS STALL, BALANGIR" addressed to the Chief District Medical & Public Health Officer, Balangir, 767001
2. The entire security amount is to be deposited in form of Bank draft drawn in any Nationalize bank in favour of Chief District Medical & Public Health Officer, Balangir has to be submitted along with the application.
3. Rs.2000/- only (Rupees Two Thousand only) towards the cost of processing fees in shape of Bank draft in any Nationalize Bank in favour of Chief District Medical & Public Health Officer, Balangir which is non refundable has to be submitted along with the application form.
4. The application will be received through Regd Post/ Speed Post. The last date of submission of application is 30.07.22 at 2.00 PM. Application received after due time will not be entertained. The authority will not be held responsible for any delay in receipt of application.
5. The applicant must write the Security Amount of stall in the application form.
6. The Advance Deposit Amount will be refunded without interest to the un-successful applicant within 30 days from the date of issue of order of allotment to the successful applicants.
7. Affidavit regarding non-availability of ZSS stall / any stall by any Government body / agency / organization in Balangir Municipality area has to be submitted with the application form on a non judicial stamp paper with appropriate value (Rs.20/-).

Conditions of allotment

1. The allotment of ZSS stall is based on lottery only.
2. The allotment of ZSS stall shall be made on the basis of which purpose/ which shop.
3. The allottee shall fit a shutter for the stall at his/her own cost.
4. The allottee shall be responsible for obtaining electricity, water supply from concerned department at his/her own cost and also pay monthly rent and any other charges as applicable on monthly basis to the authority.
5. Transfer of allotment shall not be permitted under any circumstances.
6. No transfer of allotted stall will be allowed in any case in any form of encroachment, addition and alteration of existing structure
7. The allottee is not allowed to sub-let the stall to anyone.
8. The allottee shall execute the required agreement within 15 days of issue of allotment letter.
9. Stall No.52 & 53 are reserved for Medical related services and No.50 & 51 allotted for any other service but not eateries.
10. The authority reserves the right to reject any application without assigning any reason thereof.
