Terms & conditions:

1. The sealed tender in closed envelop will be received by the DDSC-cum-Project Director, Watersheds, Bolangir on or before **28.09.2022** at 2.00 P.M. and will be opened on the same day at 3.00 P.M. by the members of the auction committee in presence of the bidders or their authorized representative in the office of the DDSC-cum-Project Director, Watersheds, Bolangir.
2. The Vehicle put to tender will be disposed off as "As is where is basis" along with outstanding tax liability if any to be paid by the accepted bidder.
3. The intending bidders shall have to enclose a Bank Draft of Rs.1000.00 (Rupees one thousand) only towards E.M.D. for the vehicle along with tender paper drawn on SBI, Bolangir in favour of DDSC-cum-Project Director, Watersheds, Bolangir. Tender without E.M.D. of Rs.1000/- in shape Bank Draft will not be considered.
4. The intending bidders may inspect the vehicle during office hours or any working day in the premises of the Office of the DDSC-cum-Project Director, Watersheds, Bolangir.
5. The E.M.D. of the unsuccessful bidders will be refunded to them on the day of opening of tender paper.
6. The bidders quoting highest price shall deposit 25% of the accepted tender price immediately on confirmation of acceptance of tender and the rest amount within 7 days and failure to pay the amount as aforesaid the deposit including earnest money shall be forfeited and the vehicle be put to fresh tender or will be considered in favour of the next highest bidder as per the decision of the tender committee.
7. The vehicle will be handed over to the successful bidder after making full payment of the accepted tender money. Tools, Implements and R.C.Book (as available) will be delivered along with the vehicle.
8. The bidder shall remove the vehicle from the site within 7 (seven) days of payment of money in full and the custody and safe guard of vehicle shall be responsibility of the bidder and no claim or complaint in the account shall be admissible.
9. Failure to remove the vehicle within the stipulated time as aforesaid ground rent 1% of the tender money shall be charged for each day or part of the day till the vehicle removed from the site.
10. Then the ground rent so charged exceed the sale price deposited, the bidder shall cease to have any right on the vehicle. The amount deposited by him shall be adjusted towards the ground rent and the vehicle become absolute property of the Govt. free from encumbrances and disposed of by fresh tender.
11. If the competent authority does not approve the bidding the amount deposited by the bidder will be refunded back without interest and acceptance of tender in his favour will be null & void.
