**ADVERTISEMENT FOR THE POST OF "JOGANA SAHAYAK".**

Applications are invited from interested candidates for engagement as "JoganaSahayak" for Sagadghat G.P. of Titilagarh Block of Balangir District for smooth distribution of PDS commodities. The selection of JoganaSahayak will be made as per the instructions laid down in letter No. 7040 dt.21.04.12, letter No.7443 dt. 27.04.12, No.13723, dated.12.08.2013, No.21547, dated.20.12.2013, No.9780, dated.10.05.2016, No.6112, dated.27.08.2018 and 20271, dated.26.09.2018 of Govt. of Odisha in F.S & C.W Department. The interested candidates fulfilling the eligibility criteria mentioned below should submit their application Forms (Format Enclosed) to the Block Development Officer by registered post/ in person. The applications complete in all respect should reach the Office of the undersigned by **20.11.2022**. Applications received after the due date in no case shall be considered.

1. The candidate should be a permanent resident of the concerned G.P
2. Minimum qualification of JoganaSahayak is 10<sup>th</sup> pass (equivalent to matriculation)
3. Weightage on career marking of 10<sup>th</sup> Pass/ +2 Pass/ +3 Pass will be given..
4. He / She should be of age between 21 to 35 years as on 01.10.2022.

**Selection Procedure:-**

The selection will be based on the career marking in 10<sup>th</sup> Pass/matriculation examination. A committee under the chairmanship of B.D.O with Inspector of Supplies as convenor and concerned Sarpanch of G.P. as member will do the selection and provide the panel of 3 names to the Collector/Sub-Collector (As decided by the Collector) for approval. Upon approval by the appropriate authority, the panel of three names so approved will be provided to the concerned G.P. for engagement of the 1<sup>st</sup> Person (scoring highest mark) as "JoganaSahayak". In case the 1<sup>st</sup> person do not join the post of J.S. within the prescribed period provided by the G.P., the person stood at 2<sup>nd</sup> place shall be asked to join the post of J.S. and if he did not join the post then the person at the 3<sup>rd</sup> Place of the panel of three candidates will be asked to join. If all the three candidates decline or fail to join the post of J.S., fresh notification will be made on receipt of information from the concerned G.P.

**Honorarium:-**

This post is on contractual basis and the amount of honorarium shall be Rs.6000/- per month which should not exceed 80 % of Retailer's margin of the G.P.

The following documents are to be attached with application form duly filled in failing which the application will not be considered for selection.

1. Attested true copy of mark sheet & certificate (10<sup>th</sup> Pass/ Matriculation)/ +2/ +3 Exam.).
