


TERMS AND CONDITIONS

1. Total Cost of the fencing Equipments to be Procured is Rs. 3, 00,000.00 (Rupees Three Lakhs) only including Tax & Transportation.
2. The selection of bidders to supply the equipment is the sole discretion of the Purchase Committee. The sample/Catalogue produced by the bidders at the time of opening of Bid shall be examined by the Committee at first and the rate of the Equipments shall be considered from the selected equipment only.
3. The Bidder or his authorized representative has to be present during opening of the tender with necessary samples.
4. The Bidder has to deposit security amount of Rs. 2,000/- (Rupees Two thousand) only in shape of Demand Draft in favour of District Sports Officer, Balangir while filling the Bid form with 3 years of tax clearance certificate. Bid filled with out deposit of EMD amount, the tender cost shall be rejected.
5. The payment of bills shall be made by the Collector, Balangir as per the approved rate incorporated in the agreement and is subject to availability of funds.
6. The supply of equipments to be executed within 30 days of receipt of the order. In case the supplier fail to supply the required items/equipments within the specified period or fail to adhere to terms and conditions on the supplied articles or found below the standard approved by the Purchase Committee, the contract shall be terminated and the EMD/Security deposit shall be forfeited.
7. In case of any complain regarding the supplied items, decisions of the District Collector shall be binding and final, who shall obtain a report from the recipient, that the supplier shall replace the same at his own cost.
8. The Supplier shall be responsible for any type of loss/damage caused during the transportation to the delivery point.
9. Collector, Balangir reserves the right to reject any or the entire Bid received without any reason thereof.
10. No request for enhancement of approved rate shall be entertained.

11. Collector/ ADM, Balangir may at any point of time terminate the contract for violation of terms and conditions of agreements without notice or any of the documents produced by the supplier.
12. The order is liable to be cancelled at any time providing 15 days notice in case any problem arises.
13. The decision of the purchase committee is binding and final in selection of the Equipments/Brand
14. The Order will be placed as per the Brand and Rate quoted by the Bidders and also due to availability of funds.
