Eligibility Craiteria : (A) POST OF PRINCIPAL

Educational Qualifications & Age Limits: (i) Retired Principal of Kendriya Vidyalaya / Jawahar Navodaya Vidyalaya with maximum age limit of 65 Years.

OR

(ii) Retired Joint Director / District Education Officer / Inspector of Schools / Deputy Director / Officers of equal status within age limit of 65 Years having Master Degree from recognized University with at least 45% marks in aggregate & B.Ed. (a course prescribed by NCTE) from an institution recognized by NCTE and affiliated to a recognized University are eligible.

OR

(iii) Retired Readers / Sr. Lecturers of Govt. colleges within age limit of 65 years having Master Degree from recognized University with at least 45% marks in aggregate & B.Ed. (a course prescribed by NCTE) from an institution recognized by NCTE and affiliated to a recognized University are eligible.

(B) POST OF PGTs / TGTs : (i) For TGTs (English, SST, Maths, Science, Odia, Hindi, Sanskrit & PET) – PGTs / TGTs in respective subject & PET of KV/ JNV/ Govt. High Schools / Fully Aided High Schools within age limit of 65 Years are eligible.

(ii) For the Post of PGTs – Retired PGTs of KV / JNV and Lecturer of Govt. & Fully Aided Colleges / Junior Colleges within age limit of 65 Years are eligible.

TENURE OF ENGAGEMENT :

The said engagement will be made till such time regular Principals/ teachers joins or the end of the academic session, whichever is earlier.

AGE LIMIT:

Minimum and maximum age limit shall be 18 and 65 years respectively.

REMUNERATION :

1. Principal - Any Station - Rs.45,000/- consolidated Pay per month
2. PGT for all Subjects - Rs.25,000/- consolidated Pay per month
3. TGT for all Subjects - Rs.20,000/- consolidated Pay per month

SPECIAL PROVISION:

Relaxation of B.Ed. qualification – In the absence of suitable candidates with B.Ed. Degrees in Hard / Very Hard station candidates with following qualifications may be considered in different categories without B.Ed. qualification.

- a) Post Graduate with 60% marks in Science Subjects and 55% in Humanities subjects may be considered for the posts of PGTs, if suitable candidates with B.Ed. are not available.
- b) In the case of TGT, B.Sc. with 60% marks and BA with 55% marks may be considered for appointment on part-time contractual basis if suitable candidates with B.Ed. are not available.
- c) Relaxation in CTET – In the absence of CTET qualified candidates, candidates without CTET qualification may be considered, if otherwise eligible.


VALIDITY OF PANEL:

The panel will be valid for One year. The district selection board can revalidate the panel on exigencies.

The engagement of retire teachers does not confer any right of engagement.

DOCUMENTS TO BE PRODUCED BY THE RETIRED EMPLOYEE:

1. Self attested copies of all certificates / mark sheets
2. Proof of retirement from service (for retired candidates)
3. Awards / Certificates of merit received during the service career.
4. Two self attested passport size colour photographs.
5. Other relevant documents
6. Undertaking to be effect that;
 - (i) No proceeding is pending against him / her at any level
 - (ii) He / she has never been convicted by any court of Law.
 - (iii) He / she is not a member of any political party.
7. One Identity proof
8. A declaration to the effect that he / she is receiving full pension. In case of provisional pension, reason to be cited (for retired candidates).
