Terms and Conditions for Supply of working Lunch & Dinner for Training/ Workshop/Meeting of DPMU, NHM, O/o-CDM & PHO, Balangir

1. The firm should submit an EMD of **Rs.5,000/-** (Five thousand) only in shape of Demand Draft / Pay Order in favour of “**ZSS Miscellaneous Balangir**” payable at **Balangir**.
2. The firm should have up to date valid food license
3. The firm should be registered under GST Act.
4. The firm should have valid PAN.
5. The firm should have adequate man power to supply the food in time.
6. The agency will supply food as per requirement & the payment will be made after completion of programme and within 7-15 days of receipt of bill.
7. The firm shall supply the food at the designated venue with its own cost; no extra charges will be made for transportation.
8. The rates quoted per plate should not exceed **Rs. 190.00** only (exclusive of GST), (Details of food items as well as price Format/Bid is enclosed at Cover -B)
9. In case of L1 prices quoted by different bidders for different items, the total avg. price per plate (taking the average of items in each Sl. No.) shall be taken into account for arriving at L1 Price.
10. The firm will enter into agreement with CDM & PHO, Balangir for supply of working lunch & Dinner for a period of one year from the date of signing of contract.
11. The food items to be supplied by the selected firm should be fresh, nutritious and prepared in a hygienic manner taking in to consideration the following factor;
 - i. Only Mustard/Sunflower oil of the branded company should be used.
 - ii. Spices & Condiments of branded company should be used.
12. The food items will be examined in each programme before serving to the participants/delegates etc, if anything found stale or unhygienic the entire food items will be thrown and the firm will be fully responsible for that.
13. After completion of the programme the supplier /agency should submit the bill along with a copy of work order if any within 7 days.
14. CDM & PHO, Balangir reserves the right to consider/reject any such proposal without assigning any reason thereof.
15. The tender will be in two parts i.e. **Technical Bid (Cover-A)** and **Price Bid (Cover-B)**. The bidders should give their **technical** and **price** bid separately in two envelopes and should be put into another cover envelop superscripted as “**Hiring of Agency for Supply of Working Lunch & Dinner for DPMU, NHM, Balangir**”. The Technical & Price Bid envelopes should be clearly marked as Technical Bid & Price Bid on the top of the relevant envelopes.
16. Bidders who qualify technically, their price bid shall be opened only.
17. Any legal dispute arising out of this is subject to jurisdiction of Balangir only.
18. Bidders may be present in person or through their representative(s) during the opening of Bid Document at **5:00 P.M** on **07 / 07 -/2023**. Even if no bidder or their representative remains present, the bid will be opened & no complain / objection will be entertained
