





TENDER SALE NOTICE OF CONFISCATED VEHICLES

Notification No.01 /Dated. 16.08.2023.

Sealed tenders are inviting in plain paper from the intending buyers for sale of the confiscated Vehicles (75nos) of the following description on "as is where is basis". The earnest money deposit for vehicles is mentioned against each in the list furnished below.

1. The EMD amount should be deposited in shape of a demand draft in favour of the Divisional Forest Officer, Bolangir Forest Division, Bolangir payable at State Bank of India, Bolangir Main Branch, Bolangir. The tender will be received from dated. **21.08.2023** during office hours and up to **5.00 PM** of **11.09.2023** in the office of the undersigned.
2. The tenderers may submit the tender by Regd. Post or in person dropping in a tender Box in this Office. If a tenderer wants to bid for more than one vehicle, then he/she has to apply in separate tender paper for each vehicle along with separate demand draft.
3. The tenders will be opened on dated. **12.09.2023** at **11.00AM** in presence of the tenderers or their authorized representative with Electoral photo Identity card.
4. The successful tenderers shall have to deposit 25% of the quoted amount and full Tax amount under GST or as per the rule in force immediately after the announcement of the tender result and the rest amount within 7 days from the date of ratification of sale and in case of unsuccessful tenderers the E.M.D. will be refunded soon after the declaration of the result.
5. In case of default in payment of highest tender amount by the successful tenderers within the stipulated period the E.M.D. and deposited amount shall be forfeited to Govt. and the vehicle will be put to fresh tender sale. The clearance of Road Tax etc. shall be responsibility of the successful tenderers.
6. The undersigned reserves the right to either accept or reject any tender without assigning any reason thereof.
7. The intending tenderers should inspect the vehicles lying in the different places as noted below on working day during office hour and relevant papers before tender sale and no complaint shall be entertained after the tender sale is completed.
8. Once the sale is ratified in the name of the highest tenderers all the liabilities, if any will be of the tenderers & no claims for any paper which are not available in this office will be entertained.
9. Once the tenderer files the tender paper, it will be presumed that he has already fully satisfied himself about the present condition of the vehicle, liabilities or availability of the relevant paper of the said vehicle.

10. The undersigned is not bound to accept the highest tender & reserves the absolute right to accept any tender or reject any or all the tenders without assigning any reason thereof.
11. The intending tenderers are required to submit copy of Voter Identity Card or any other authentic identity for their identification along with the tender papers.
12. The successful tenderers shall remove the vehicles from the site within seven days from the date of depositing the full tender amount, failing which ground rent at the rate of 1% of tender money shall be charged for each day or part of the day till removal of the vehicle from the site. Custody or safeguard of the vehicle shall be the responsibility of the tenderer and no claim or complaint on that account shall be admissible. Where the ground rent so charged exceeded the sale price deposited, the tenderers shall cease to have any right on the vehicle.
13. The amount deposited by him shall be adjusted towards the ground rent and the vehicle shall become absolute property of Govt. free from all encumbrances and dispose off by fresh sealed tender as the case may be.
