Sub: - Mobilisation of farmers for submission of documents with regards to multiple registration of application in a plot under PMFBY for Kharif 2023.

To

It is come to the notice of the undersigned that 15088 nos of applications (in soft copy) have been found multiple insurance in a plot, 18839nos of application found wrong relative name as compare with the registration made in previous year which needs to be verified for establishing the genuineness for enrollment under PMFBY Kharif 2023. For this following protocol to be adopted for verification of application.

- A public notice should be given to the farmers involved on the issue to submit their documents. Further, the same should be displayed on district Website & notice board of all Tahasil/BAO/AAO/Block office
- 2. The notice should be displayed in all the GPs.
- 3. A link of the rejected list of the block should be displayed in all the GP office.
- 4. The farmers should visit the office of Tahasildar concern for verification (till 12.10.2023) from 10 AM to 5PM.
- 5. The concern Agriculture staff/AAO/BAO of the block will be present to receive the application and cooperate in the process of establishment of genuineness of the farmer application.
- 6. The genuine farmer should apply with the following documents
  - i) Genealogy Proof (if the RoR does not contain the name of applicant)
  - ii) Xerox RoR copy/Possession certificate issued by the competent authority.

iii) Copy of Aadhaar card

iv) CSC acknowledgement on PMFBY enrollement

- A certificate on undertaking to take criminal action in case of fraudulent in claiming insurance (Annexure – 1)The last date of submission of application is 12th of Sept'2023.
- 8. For creating awareness awareness among the farmers PRI members should be sensitized.

- 10. Message should be sent in the GP level farmers group for submission of documents at office of Tahasildar of concern block to establish the genuineness of enrolled farmer under PMFBY 2023 Kharif.
- 11. The BAO/AAO of the block will assist the entire process of verification work and Block representative of insurance company will provide details data at the time of enquiry.
- 12. The verified report must be signed by the Tahasildar, BAO/AAO & representative of Insurance company.

It may be noted for make general awareness, that any person fraudulently claiming insurance under PMFBY shall be booked under rule relevant provisions of Indian penal code.
