Expression of Interest (EOI) for Wall Painting at GP Level for the Year 2023-24

Expression of Interest (EOI) is hereby invited by the Chief District Veterinary Officer, Balangir from the intending bidders/ reputed firms for Wall Painting work at GP Level. The EOI documents must be submitted through registered post/ Speed Post service latest 02.01.2024 by 5 PM. The EOI should reach in Sealed cover with superscribing with EOI for Wall Painting under IEC schemes of CDVO, Balangir.

GENERAL INSTRUCTION TO THE BIDDER

This tender is floated in 2 Bid system for wall painting.:

1. Wall painting is to be done at prime locations at 317 G.P. head quarter villages.
2. Bidders who are participating shall have to submit a sealed price bid and a technical bid.
3. The tender document shall accompany with on EMD of **Rs. 20,000/-** (Twenty Thousand). The EMD should be in favour of CDVO, Balangir in form of DD. EMD may be forfeited if they withdraw or modify their bids/violate the terms & conditions of EOI.
4. At any point of time, the Tender Inviting Authority reserves the right to reject the tender without assigning any reasons thereof.
5. The bidder(s) shall have to submit their tender in separate sealed envelopes, i.e. one for technical bid by superscribing Cover "A" (Technical Bid) & Cover "B" (Price Bids). The Technical Bid and Price Bids should be put in to a third Cover, which should be superscribed as "**Tender for Wall painting**". On this cover the address of sender and Receiver need to be clearly mentioned.
6. The Sealed tenders "Cover A" (Technical Bid) submitted by the bidders will be opened at the Office of the CDVO, Balangir by the Tender Evaluation Committee in presence of Bidders or their authorized representative. In situation of absence of participation of Bidder/ authorized representative during the process of opening of Technical bid cannot be stopped. The bidder will have no right to claim any sort of imposition to make the process null and void. But due to any unexpected untoward situation, if the process of opening of technical bid has to be stopped, the notice for next date of opening the technical bid will be displayed in the office notice board and also it will appear in the official website of Collectorate, Balangir. The Technical Bids will be opened on Date 3.1.2024 at 11 AM. Price bids of successful bidders in the

technical evaluation process will be opened and evaluated just after technical evaluation on the same day.

7. No tender documents shall be accepted after the expiry of scheduled date and time.
8. In the price bid, rate should be quoted in Indian Currency (with paisa in two decimals only), both in words and figures including GST.
9. The tender documents should be clearly written/typed without any correction, interpolations, and overwriting. Each page of the tender should be page numbered with the dated signature of the bidder. If any information or documents furnished by the bidder found to be misleading/incorrect at any stage, their tender will be rejected.
10. The interested bidder can download the Entire Tender Document from the website <https://balangir.nic.in>. He can have the tender documents from office of the CDVO, Balangir from accounts section by making a Govt. deposit of Rs.1000/- (Rs. One thousand only) towards the tender processing fee.
11. The firms desirous to participate in the bid process shall have to submit Tender Processing fee in shape of Demand draft of Rs.1000/- (Rs. One thousand only) drawn at any Nationalized bank in favor of "Chief District Veterinary Officer, Balangir". The demand draft or Govt. money receipt of Rs.1000/- is to be attached with the Technical bid documents.
12. The price bid should be submitted in the given format (Annexure-III)

1.Evaluation:

- i) Tenders will be evaluated as per the requirement of the bid and the price bid (Cover-B) shall be opened only for those bidders who will qualify in the technical evaluation.
- ii) The cost of the unit item including Taxes/ GST will be evaluated.
- iii) If the approved lowest eligible firm/agency fails to perform the work within the stipulated period of rate contract, to meet the need, the tender inviting authority reserves right to order the same from the L2/ L3 firm/agency at L1 rate, if they agree to perform at L1 approved rate or negotiated rate.

ELIGIBILITY CRITERIA:(SELF ATTESTED DOCUMENTS REQUIRED TO BE SUBMITTED)

The firms eligible to participate in the tender process provided, they have the following

eligibility criteria.

1. The bidder must be a registered company under the Indian Companies Act or registered individual/ Partnership firm or Proprietorship firm.(Copy of registration certificate is to be attached)
2. The bidder should have valid GST registration for legally carrying out its business activities with up-to-date return filing copies.
3. The bidder should have a valid PAN. The bidder shall provide the details of the ownership of the company.
4. The bidder should have a local office in state of Odisha.(Proof should be attached)
5. The bidder should have a minimum turnover of Rs. 40 Lakh in each year for three years (i.e. FY 20-21, FY 21-22, FY 22-23). The bidder must submit annual turnover certificate of three financial year duly certified by C.A (indicating the membership no. of C.A with Seal) ending on 31.03.2023 with audited balance sheet of last three financial years with the income tax return filing of said three financial years (Annexure – II).
6. Minimum 1 years of experience in Wall painting in Govt. / PSUs (Work order to be furnished)
7. The bidder must not have been barred or blacklisted by any State/ Central Government Departments/ Govt. Agencies or any PSUs (An Affidavit to this effect shall be furnished).
8. The Agencies should not have indulged in any criminal offence (An Affidavit to this effect shall be furnished).
9. Profile of the Agency should be submitted.(Annexure – I).
10. The company/agency should have a positive Net worth certified by C.A of last 3 financial years.
11. The Periods of engagement of selected agency shall be for 2 years from the date of selection.
12. The tender document shall accompany with an EMD of Rs. 20,000/- (Twenty Thousand). The EMD should be in favour of CDVO, Balangir in form of DD. EMD may be forfeited if they withdraw or modified their bids/violet the terms & conditions of EOI.
