

ICDS PROJECTS OF BOLANGIR DISTRICT)
18. The bidder who qualify in technical bid will be eligible to participate in financial bid.
19. Technical specification for printing and supply of Nua Arunima Workbook I & II, Child Assessment Card, Picture/numeracy books, Kuni Calendar is given at Annexure-C.
- 20.. The Agency finalized for printing shall supply a sample of Nua Arunima Workbook I & II, Child Assessment Card, Picture/numeracy books, Kuni Calendar as per specification.
21. The Agency finalized for printing have to give an undertaking that he/she has understood the expected quality and quantity of the products.
22. Quality of printing materials shall not be compromised and have to be as per Govt. specification.
23. The printing firm cannot redesign or modify printing and size of Nua Arunima Workbook I & II, Child Assessment Card, Picture/numeracy books, Kuni Calendar and all must be as per Govt. specification.
