The vehicle must be Road worthy conditions, shall not be more than 3 years old from the date of Initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, valid contract carriage permit proof of up to date tax payment etc. which are mandatory for paying of vehicle.

- 1)The driver of the vehicle must have a valid Driving Licence for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
