



2. Scope of Work

The scope of work is comprising of supply of Food Items and Training Kits of the required specification and quality. The selected bidder is required to make supply and distribution of food items at District Headquarter and Blocks point will be intimated by the undersigned. The Training Kits will be supply at DPRC, Balangir.

3. GST & Income Tax Certificate

The firm/ dealer must have valid GST certificate, PAN card and Income Tax Return details of least 2 years i.e. financial year 2021-22 & 2022-23.

4. Experience

The Organization has supplied by similar types of work during in the last continuity 2 years in Balangir district. Copy of work order clearly specifying the works (submit necessary documents with photo copy details).

5. Turn Over

The bidder must have an average annual turnover of Rs.25.00 lakhs In the presiding two financial year i.e. 2021-22 and 2022-23 for supply of Food and Rs.5.00 lakhs In the presiding two financial year i.e. 2021-22 and 2022-23 for supply of Training Kit.

6. EMD

The bidder shall submit EMD of 25,000/- (Rupees Twenty five thousand) only for Food and Rs.10,000/- (Rupees Ten thousand) only of Training Kit in favor of C.D.O-cum-Executive Officer, Zilla Parishad, Balangir in shape of TDR or Bank Gurantee.

7. Undertaking as to litigation/Black Listed

The bidder shall submit have any legal suit/ criminal case pending / black listed against it for violation of PF/ESI/MW Act or any other law. (Submit declaration for no case pending).

8. Declaration

The bidder shall submit declaration that the organization agrees to abide by all term & conditions of Quotation.



9. INSTRUCTIONS TO BIDDERS

General Instructions

- Interested bidders are advised to view the detailed Quotation documents at www.balangir.nic.in or can be obtain from Zilla Parishad Office, Balangir.
- Bidders desirous of participating in the Quotation shall have to pay the Quotation cost mentioned in notice inviting Quotation. The Quotation cost is required to be paid in shape of Demand draft only, drawn from any nationalized bank in favor of C.D.O-cum-Executive Officer, Zilla Parishad, Balangir and payable at Balangir. The Quotation cost is exclusive of GST and is not refundable.
- Earnest money as specified in bid shall be deposited in shape of TDR or Bank Gurantee from any nationalized bank in an acceptable format the time of submission of bid.
- Bid securities of the unsuccessful bidders shall be returned to them within 02 weeks of the selection of successful bidder.
- Bidding Partnership firms are required to submit complete partnership deeds along with the bid documents.
- The supplied materials shall strictly comply with the specifications as mentioned in the bid, otherwise the material shall be liable for rejection.
- Since timely execution of works is the essence of the contract, requests for extension of time for supply shall not ordinarily be entertained.
- Notice inviting Quotation, bid documents, prescribed Technical bid, financial bid, terms & Conditions shall form the part of the Quotation.
- All Taxes applicable at the time of supply may be admissible.
- Besides, EMD, the bidder shall have to submit performance security 3% of the contract value in shape of TDR or Bank Gurantee in favor of C.D.O-cum-Executive Officer, Zilla Parishad, Balangir payable at Balangir and it should be valid beyond 60 days after the end of a contractual obligations or warranty obligations.
- **The EMD may be forfeited in case**
 - I. The Bidder withdraws its bid within validity period of 90days.
 - II. The Bidder does not respond for clarification of bid.
 - III. The Bidder fails to provide the required information during the evaluation process.
 - IV. The Bidder submits false information.
 - V. The Bidder fails to sign Agreement in time or does not furnish Performance Security i.e.3% of the Contract value.
 - VI. The Bidder materially alters his Bid during the Bid processing period.
- Zilla Parishad, Balangir will not be responsible for any incidental or consequential losses of the firms while execution.
- Deviations in terms and conditions, specification of material, in section clause etc. Will not be accepted under any condition.



- Prices quoted must be firm and fixed; it shall be quoted in both figure and word. It should be Inclusive of GST & transportation cost.
- Conditional Quotation shall not be accepted.
- Canvassing in any manner shall not be entertained and will be viewed seriously leading to rejection of the bid.
- All the documents submitted by the Bidder shall be self-attested or else liable for rejection.

Opening of Financial Bid

- If the Technical Bid is found complete and responsive, the financial bid will be opened.
- Bid shall be awarded to the venders(s) / Catering Agencies/ Hotel/ SHG Federation/ Group of person / Individual offering the lowest/net bundled price and not with reference to lowest prices quoted for the sub-items. However, if prices for each and every item are not quoted, bid shall not be accepted.

14. Settlement of Dispute

In case of any dispute arises between the supplier and purchaser shall be tried to resolved amicably by mutual understanding. If the party fails to resolve the dispute within 21 days shall be settled through arbitration under the jurisdiction of Balangir Court on as per Indian Arbitration and Conciliation Act-1996.

15. Payment

Payments shall be made after successful supply of foods items and Zilla Parishad level committee authorized by C.D.O-cum-Executive Officer and if found satisfactory.
