
Copy along with copy of Gradation Lists forwarded to all Block Education Officers of Balangir District for information and necessary action with a request to circulate the gradation lists amongst the teacher concerned of their Block and submit the objection, if any, along with supporting documents to the undersigned with their views & obtain signature of the teacher concerned as a token of verification entries made therein in the provisional gradation list. Further, they are requested to re-check the entries in the gradation list as per eligibility criteria/examine the objection received from the teachers with reference to the original Service Book and other valid document(s), make necessary correction/incorporate valid objection in draft gradation list and submit it to the undersigned by **25.07.2024** positively and ensure submission of CCRs as well as Property Statement by the teacher concerned as per this office letter No- 2054 dated 10.03.2023. Further, the BEOs are directed that, in case of teachers who have submitted Academic/ Training qualification certificates outside Board/ University of Odisha at the time of their appointment or acquired subsequently, their case must be verified minutely and kept in records in their office for future reference and undertaking in this regard shall be obtained from the teacher concerned that, " If any fake / forgery/ manipulation of certificates detected later on, he/she shall be terminated from service without assigning any reason thereof".


