- 1) The intending bidders are advised to inspect the unserviceable items on any working day during the office hours between 11 A.M. to 4.00 P.M and the bidders shall have to deposit Rs. 500/- (Rupees Five Hundred) only in shape of Cash towards security deposit before commencement of the bid and requested to remain present on the date, time and place mentioned above to offer their bids.
- 2) The successful bidder shall have to deposit the full amount of the bid and take delivery of the aforesaid dead stock items on the spot immediately from the office at his/her own arrangement. Any type of untoward situation or any loss/ damage/theft occurs within the period of removing of materials from DIC Balangir premises the loss will be borne by the bidder. The security deposit shall be refunded to the unsuccessful bidders soon after the auction is over.
- 3) The security deposit of the successful bidder shall be forfeited if he fails to remove the aforesaid dead stock items on the same day from the office by paying the full amount of the bid minus the security deposit of Rs.500/-
