- 1) The Sub-Collector-Cum-Chairman Regulated Market Committee, Balangir invite rate quoted bid in sealed cover from reputed manufacturer/ authorized registered dealers for supply, installation and commissioning along with AMC charges of grading equipment (i) Electronic Weighing Scale (300) KG Capacity (Without Printer),(ii) Mini Weighing Scale (05) KG Capacity (iii) Mini Grader, (iv) Analysis Kit, (v) Digital Moisture Meter (With Printer) of latest version with compatible Bluetooth and USB connection which can be paired with any other device as per technical specification issued by OSAM Board, Bhubaneswar Vide Letter No.3252 (66) dated.30.10.2018 and letter No.1729 (66) dtd.20.08.2019 in plain paper with proper format and seal and signature within the specified time period.
- 2) The bidder should be an Original Manufacturer or Authorized Dealer of the equipment / item stated above and capable of providing adequate and timely after sales services.. Necessary proof towards bidder being a Manufacturer or its Authorized Dealer should be submitted along with bid.
- 3) The bidder should have successfully supplied these products for agricultural marketing appliance in Odisha or in any State/ Institution/Organizations.
- 4) The bidder should submit attested Xerox copies of valid Manufacturer/Dealership Registration Certificate, GSTIN, GST Clearance Certificate and PAN Card and authorization certificate (if not an original manufacturer) etc. along with the bid.
- 5) The bid document must be enclosed with an EMD amounting of Rs.1,00,000/- (Rupees one lakh )only in shape of Demand Draft drawn in any Nationalized Bank payable at Balangir in favor of Secretary, Regulated Market Committee, Balangir.
- 6) In case of Electronic Weighing Scale 300 Kg Capacity it is of plain type without printer Facility. It should be duly verified and stamped by Legal Metrology, Govt. of Odisha for the first year.
- 7) The Bidder must submit two envelopes for technical bid and financial bid separately.

- 8) The Bidder should enclose detailed write-up along with necessary technical specification /document/drawings and design for all the makes and models in the bid.
- 9) The Tender / Bidders having ISO Certification with at least 5 years' experience of both sales & Service, having own authorized service center in Odisha to extend service support for 24/7 and when required on priority basis, shall be given preference over others, for which bidder may submit documentary evidence towards same along with bid.
- 10) No conditional offer/undertaking will be accepted.
- 11) All price quoted should be inclusive of all taxes and delivered at R.M.C destination point.
- 12) All equipment must cover at least 1 year warranty.
- 13) The bidder should quote the AMC rate for each item for three consecutive years after successful completion of warranty period.
- 14) The successful bidder must supply the equipments within 7 (Seven) days of issue of supply order, failure to which the supply order will be cancelled.
- 15) Legal Metrology license like Manufacturing, Dealership, Repairing and Model approval issued by Directorate of Legal Metrology Department, Government of Odisha should be attached with bid.
- 16) Bidders should depute their representative for demonstration of different equipment on dt.12.11.2024 at office of the R.M.C Balangir.
