TERMS & CONDITION

1. The engagement is purely temporary and terminable at any time without notice and without assigning any reasons thereof.
2. The candidates should join in their place of posting within 07 days from the date of receipt of the order failing which the engagement order in respect of the concerned candidate shall stand automatically cancelled.
3. They should produce a medical certificate as required provision of Rule from the Competent Authority at the time of joining.
4. Two-character certificates from two gazette officers not below the rank of Group-B Officers shall be produced.
5. A declaration of the effect that he/she is having not more than one spouse living, if married, should be produced.
6. HSC Certificate for verification of Date of Birth and essential qualifications & all other original certificate/ experience with 02 attested copies each in original shall be produced during the time of joining.
7. A declaration regarding him/her age shall be submitted before the authority where she/he shall be joined.
8. Two recent color passport size photographs should be produced at the time of joining.
9. No Objection Certificate from the current employer.
10. Suppression of correct information or furnishing of false information in application shall render for disengagement in addition to other legal action.
11. No TA will be allowed to join in the present place of posting.
12. The tenure of the Aspirational Block Fellow will initially up to one year. Further, contingent upon the satisfactory performance of AB Fellow and demonstrated contribution to the programme objectives as determined by the State Government, the programme may allow for an extension of one year of the fellowship.
