### QUOTATION CALL NOTICE


Sealed quotations are invited from the intending registered dealers / suppliers to quote the rate for procurement of 20 nos. of 12 Volt Capacity 42AH-EXIDE POWER SAFE, VRLA / SMF Batteries for online UPS with 2 years warranty as well as exchange of old and unused batteries of this office within 15 days from the date of issue of the Quotation Call Notice to the District Industries Centre, Balangir. The sealed quotation should reach the undersigned by 18.02.2025 at 5.00 P.M. as per the terms & conditions given below.

#### Terms & Conditions.

1. Sealed Quotations should be submitted after completion in all respects by Regd. Post/ Speed Post to the Office of the General Manager, District Industries Centre, Balangir, which should reach this office on or before the scheduled date and time. The last date for receipt of sealed quotations through Regdpost/ Speed post to the Office of the General Manager, District Industries Centre, Balangir is on dt 18.02.2025 up to 5.00P.M.
2. Sealed quotations will be opened on 19.02.2025 at 3.30 P.M. by the undersigned in this office in presence of all quotationers or their authorised representative and members of purchase committee constituted for the purpose.
3. The quotation received after due date and time & incomplete in any manner will be rejected. The General Manager, District Industries Centre, Balangir will not be liable for postal delay if any.
4. Format of the quotation as well as terms and condition are available in the notice board of this office of the undersigned as well as in the district website.
5. The relevant documents should be duly signed in all the pages by the Dealers/ Suppliers or the authorized representative on behalf of the dealers / suppliers with seal, signature & date of the firm.
6. The District Industries Centre, Balangir shall not be responsible for accidental opening of the covers that are not properly superscribed and sealed before the time notified for opening of quotations.
7. Submission of more than one competitive quotation by the same dealers/ suppliers in response to the Quotation call notice is prohibited. All such quotations except one received first will be cancelled at the discretion of the authority inviting the quotation.
8. Copy of the valid Registration Certificate issued by Competent Authorities under the GST Act alongwith the GST return for the last 3 months in GSTR-03B and copy of the PAN No. with return of the tax for the last 03 months shall be enclosed with quotation. In no case other certificates issued by authorities in lieu of such certificate shall be accepted.
9. The participant agencies should submit the company registration certificate/partnership deed or SSI Registration, etc. as applicable.

10. The firm should not be blacklisted anywhere and an authorized declaration should be provided along with the quotation.
11. Interested suppliers / dealers may visit this office located near Civil Court, Patnagarh Road, Balangir during office hours to find out the condition of old batteries, if requires.
12. The rate quoted should be inclusive of taxes , etc. The tax components should be indicated separately with percentage of tax.
13. The finalization of registered dealers / suppliers shall be based on the L-I rate.
14. The warranty of the Batteries should be minimum of 2 years or more from the date of installation of Batteries.
15. Installation & transportation etc. if any may be indicated in quotation.
16. Payment shall be made after receipt of materials in good condition & in the mode of Electronic Fund Transfer (EFT) or e-payment by cheque. The selected suppliers / dealers, should indicate EFT No. and other relevant details in their office/bills(s). Banker's name , address , type of a/c and a/c no and IFSC no. etc.
17. No claim for price increase will be entertained during the purchase period.
18. The General Manager , District Industries Centre, Balangir reserves the right to reject /cancel any or all the quotations without assigning any reasons thereof. This purchase / sale is subject to the jurisdiction of Courts of Balangir only.
