





TERMS & CONDITON

1. The intending bidders shall have to furnish tender paper cost of Rs, 6,000/- (Rupees Six thousand only) in shape of demand draft in favour of the Executive Officer, Balangir Municipality payable at Balangir along with the quotation which is non refundable.
2. The intending bidders shall have to furnish EMD of Rs. 20,000/- (Rupees Twenty thousand only) in shape of demand draft in favour of the Executive Officer, Balangir Municipality , Balangir along with the quotation in the prescribed form vide Annexure-2. EMD of successful bidder will be release after audit clearance.
3. The intending bidders shall have to submit PAN No & GST Regd. no.
4. Quotation without tender paper cost, EMD, PAN No. & GST Regd. No. shall be rejected.
5. The successful bidder shall have to install temporary shed/kiosk at each location along with water pot, Mug, Glass, fixing of banner and availability of safe drinking water with manpower from 08.00 AM to 05.00PM on daily basis w.e.f. 15th March-2025 to till 15th June- 2025. This may be extended further as per requirement of this office.
6. The list of locations within Balangir Municipality area for Jalachhatra shall be provided by this Office along with work order.
7. The payment of bill of Jalachhatra shall be paid to the successful bidder only after satisfactory performance report by the concerned **Sanitation Expert and Ward officer** of Balangir Municipality. The payment of individual manpower engaged in the Jalachhatra shall be made through individual account transfer.
8. If any grievance received regarding water quality and manpower availability for distribution of water at any Jalchhatra kiosk/shed Rs.1,000/- per day per kiosk penalty will be imposed. For any other grievance Rs.5,000/- per day per kiosk penalty will be imposed if it will not resolved within 4(Four) hours.
9. The selected bidder shall have to execute an Agreement with the Balangir Municipality in this regard.
10. The lowest quoted rate in cumulative will be considered.
