



1. Eligibility Criteria

a. The bidder should be a legal entity such as Company/ Proprietorship Firm/ Partnership Firm/ Original Equipment Manufacturer (OEM)/ Authorized Dealer/ Bid specific vendor/Authorized Business Partner registered under relevant act(s)/ rules in India. (Copies of Incorporation/Registration certificate to be enclosed).

b. The bidder should have minimum annual average turnover of Rs 60.00 Lakhs during the last 03 (three) Financial Years i.e, FY 2021-22, FY 2022-23 and FY 2023-24 (Turnover certificate duly certified by CA and copies of ITR, Balance Sheet and Profit & Loss Account Statement to be submitted).

c. The bidder must have executed minimum two work orders of supplying at least 2 (Two) similar Backhoe Loader Excavators to any Central/ State Government/ PSU / ULBS etc. during the last 05 years in India prior to the date of issue of this quotation. (Copy of Work Order/Completion Certificate to be submitted).

d. The bidder should have not been debarred/ blacklisted by any Central / State government department / public sector undertaking / other government entities or local body in last 05 years in India prior to the date of issue of this Quotation. (Undertaking to be submitted on non-judicial stamp paper).

e. The bidder should have valid PAN Card and GST registration certificate.

f. If the bidder is a dealer, then the bidder shall submit the authorized dealer/ authorized business partner certificates of the Original Equipment Manufacturer (OEM) along with the technical bid documents. In case bidder is an Original Equipment Manufacturer (OEM) of the Backhoe Loader Excavators and intended to supply under this tender then a certificate of registration under MSME/ NSIC/ DIC/ Registrar of Companies needs to be provided.

g. The bidder through its authorized service center/ workshop/ office available within the jurisdiction of Odisha shall provide the required maintenance services and further the bidder shall submit the name and details of the service engineers (min. 2 nos.) working in the authorized service center or workshop. The bidder shall submit authorized service center certificate in this regard.

h. Conditional proposals submitted by the bidder shall stand cancelled.


2. Term & Conditions

- a. The successful bidder shall strictly adhere to the standard technical specification provided in the quotation paper for supply of Backhoe Loader Excavator to Balangir Municipality.
- b. The Backhoe Loader Excavator must be approved by Bureau of Indian Standards (BIS). The approval certification needs to be submitted by the bidder.
- c. The successful bidder shall ensure supply of the Backhoe Loader Excavator within 15 days from the date of issuing of work order
- d. The successful bidder at its own cost shall deliver all the Backhoe Loader Excavator with its accessories to Balangir Municipality and shall do the required comprehensive insurance of Backhoe Loader Excavator.
- e. The successful bidder shall provide on job training and arrange time to time technical orientation session for the persons nominated by Balangir Municipality on preventive/scheduled/ breakdown maintenance of Backhoe Loader Excavator.
- f. Any problem related with maintenance shall be attended & rectified by the selected agency/ supplier during the warranty period.
- g. The successful bidder will undertake preventive maintenance measures as a part of overall responsibility for maintenance of the Backhoe Loader Excavator during the warranty period.
- h. All materials/ parts/ spares provided shall be of good quality from reputed manufacturers.
- i. Copies of all operation and preventive maintenance manuals etc. should be provided of the vehicle and equipment at the time of delivery of vehicle and equipment to Balangir Municipality.
- j. The successful bidder shall have to provide warranty of 01 (one) years or above on the Backhoe Loader Excavator. The successful bidder has the responsibility to supply and provide services against any manufacturing/mechanical defects. The bidder should provide the details of parts, equipment's, spares, etc. coming under the warranty.
- k. During the warranty period, the successful bidder at its own cost shall undertake routine checkup of the vehicle and all its parts in every three months till completion of the warranty period. If there is a requirement of replacement/ repair of any part, the same must be resolved within 24 hours by the successful bidder. The successful bidder shall ensure that each part of the vehicle to be supplied/ replaced shall be new and the bidder shall submit a list of replaced part in this regard to Balangir Municipality.
- l. Maintenance work during the warranty period such as greasing, and lubrication shall be carried out by the successful bidder by its own or through its authorized dealer for free of cost.
- j. In the event of any correction of defects or replacement of defective parts is undertaken during the warranty period, then warranty for the corrected/replaced part shall be extendable to the period as per applicable rules of the OEM of the corrected/replaced part. A certificate in this regard shall be submitted by the successful bidder.
- k. In case of breakdown of Backhoe Loader Excavator etc. during the warranty period, the Balangir Municipality reserves the right to hire/lease the Backhoe Loader Excavator from elsewhere at the risk and cost of the successful bidder and the Balangir Municipality shall recover all such extra cost from the payments to be made to the successful bidder or from the Performance Security submitted by the successful bidder.
