6. The bidder is required to submit Bid Security (1% of tender amount).

7. The Successful bidder is required to submit the Annual Performance Security (as per the latest circular of Govt. of Odisha) in shape of **T.D.R, NSC, KVP** Pledge in favor of **Deputy Director of Horticulture, Bolangir**, if their quoted amount is less than the estimated cost.

8. As per the Rule -13 of Appendix-VIII OPWD Code Vol-II, the contractor has to deposit 1% bid amount at the time of drawal of Agreement as Initial Security Deposit.

9.Besides, C&D Class contractors will be required to furnish security deposit deduction will be made at the rate of 3% of the gross amount of each bill. This will be refunded to the contractor after 6-month completion of the work.

10. The contractors are required to provide IT 1% of the gross amount, CGST and SGST 1% each of estimated cost, and Labor CESS 1% of the estimated cost as a deduction from their bill.
