TENDER PAPER

Terms and conditions:

1. The sealed tender in prescribed pro forma should be super scribed as “**Supply of Chemicals, Reagents & Consumables for Maglumi 800 (CLIA) Analyzer**” to **Bhima Bhoi Medical College & Hospital, Balangir for the year- 2025-26**”. are to be submitted in the office of the undersigned on or before **21.04.2025 by 05.00 PM** through Regd. Post/Speed Post / Courier only and the tender will be opened on **22.04.2025 at 10.30 AM** in presence of either the tenderers or their authorised representatives in the office chamber of the undersigned. The tenders received beyond the scheduled date and time will not be considered under any circumstances.
2. The tenderer should enclose the Demand Draft towards tender document fees in Technical Bid (Cover-A).
3. The tenderer should furnish the EMD of **Rs. 50,000 /- (Rupees Fifty Thousand only) in shape of Demand Draft only** in favour of Superintendent, Bhima Bhoi Medical College & Hospital, Balangir payable at Balangir issued from any Nationalised Bank or RBI approved bank. The EMD of the unsuccessful bidders will be returned after completion/finalization of tender process & for successful bidders, the EMD amount will be kept as Performance Security. The performance security amount will be returned without accrual of any interest after completion of the tender tenure, if performance was satisfactory throughout the tender tenure. In case of selected Local MSME Manufacturer having valid **MSME certificate (Category- Manufacturer)**, Who have claimed exemption of EMD, have to deposit performance security of **Rs. 50,000 /- (Rupees Fifty Thousand Only)** in shape of demand draft in favour of Superintendent, Bhima Bhoi Medical College & Hospital, Balangir. For **Local MSME (Category- Manufacturer)** selected manufacturer, the performance security amount will be returned after completion of tender tenure without accrual of any interest.
Note: Micro & Small Enterprise(MSE) are exempted from the payment of EMD as per MSEs order, 2012 and Policy Circular No. 1(2)(1)/2016 - MA, Ministry of MS & ME dated 10th March 2016 if valid registration certificate from NSIC/MSME is submitted self-attested copy with Technical Bid for the product for which bidder has submitted quotation.
4. After finalization of Technical Bids by the committee, the Price Bid (Cover-B) of the successful firms who qualify in the technical specification will be opened by the committee on another date as fixed by the Superintendent in presence of either the tenderers or their authorised representatives. If any tenderer or their authorised representatives fails to turn up at the time of opening of the tenders, the process will continue as usual.
5. The tender documents should be clearly written/ typed without any corrections, interpolation and over-writing etc. and each page of the tender should bear the **dated, signature and the page number** of the tenderer.

11. The reagents etc. to be supplied must have expiry of at least one year on the date of supply and they have to supply the Demo Kits for quality assessment to different departments if required.
12. If any information or documents furnished by the tenderer found to be misleading or incorrect at any stage, their tenders will not be evaluated.
13. The rates so quoted should be on door delivery at the Central Laboratory, Bhima Bhoi Medical College & Hospital, Balangir.
14. The tenderer should submit up to date printed price list of products.
15. The committee will accept the Highest Discount Offered by the firm/ tenderer.
16. The committee is not bound to accept the Lowest bid and/or Highest Discount Offer considering the quality aspects / performance aspect based on our past experience w.r.t. the product quoted, which cannot be contested by the bidder.
17. The tenderer should submit the up to date Photostat copies of the valid GST certificate as per Govt. rule, valid PAN card, valid ID proof, E-mail ID & Contact No, valid ISI/ISO/GMP certificate, Valid Drug Licences, valid manufacturing license/ Authorization certificate for the items.
18. The tender will be valid for one year from the date of approval and may be extended on review on mutual agreement with the same terms and conditions subject to satisfactory performance / till finalization of next tender.

25. Proof of average Annual Turnover of Manufacturers / Suppliers of **Rs.1 Crore or more** in last three financial years (2021-22, 2022-23 & 2023-24) taken together duly signed by a practicing chartered Accountant shall be submitted in format given in **ANNEXURE –III**.
26. The price bid in the prescribed format (as per **ANNEXURE-IV**), must be submitted inside sealed price bid cover with Super scribing “**PRICE BID**” on it.
27. Tenderer who has been black listed in last one year either by the tender inviting authority or by any state Govt. or central Govt. organization should not participate in the tender.
