Depot of Bolangir District to WSHGs points and Foodstuff (Rice) from OSWC/CWC of Bolangir District to Anganwadi Centre Points for under SNP Feeding Programme in Bolangir district during the year 2025-26

**DETAILED TENDER NOTICE FOR APPOINTMENT OF
TRANSPORTING AGENT UNDER THE SUPPLEMENTARY NUTRITION
PROGRAM FOR THE YEAR 2025-26**

Sealed Tenders in the prescribed form are invited from intending Registered Transport Contractors/Transporting Agent/ WSHGs having valid Agent License for undertaking transportation of Foodstuff (Wheat) from F.C.I. Depot of Bolangir District to WSHGs points and Foodstuff (Rice) from OSWC/CWC Godown, of Bolangir District to Anganwadi Centre Points under SNP Feeding Programme in Bolangir district for the year 2025-26. The approximate quantity of foodstuff to be handled in a year and approximate value of the foodstuff in the Government rate is appended below.

Approximate quantity of foodstuff in quintal (Quarterly) = Q.11550

The tender shall be received by the DSWO, Bolangir on behalf of Collector, Bolangir on or before Date. **16-04-2025 up to 1 P.M** and the tender will be opened at 10.00 A.M. on Date. **17-04-2025** in the Conference Hall of Collectorate, Bolangir in the presence of Tender Committee members and the Tenderers or their authorized representatives by producing the letter of authorization. The tender received beyond the date and time shall be liable for rejection.

The tender will be in Two parts i.e. Technical Bid (Part-1) & Financial Bid (Part-2). The Tenderer should submit their Technical & Financial Bid separately in two envelopes and put into another cover superscribing in the Capital Letters such as "TENDER FOR UNDERTAKING TRANSPORTATION WORK UNDER SNP FEEDING PROGRAMME IN BOLANGIR DISTRICT DURING 2025-26.

Firms should downloading Tender paper from District Website to submit the tender documents must enclosed DD amounting to Rs. 5000.00 (Rupees Five thousand) only in favour of DSWO, Bolangir payable at Bolangir

As per guidelines of W&CD Department, Odisha, Bhubaneswar the ceiling limit for transportation charges of wheat from FCI Depots to WSHG Points / Rice from OSWC Godown, to AWC Point is Rs.150.00 (Rupees One hundred Fifty Rupees) only per quintal.

TERMS AND CONDITIONS OF THE TENDER

1. The Tenderer shall carefully go through all the terms and conditions of the tender documents and submit the tender paper correctly and in complete form. The tender paper should be filled in properly and legibly without any correction/overwriting. No opportunity shall be given to the tenderer to rectify or amend any defect detected at the time of scrutiny. The

rates should be written in both the words and figures in the tender schedule. The rate quoted should be final and the tenderer shall not be allowed to change the same under any circumstances and it should be valid for the year 2025-26.

2. No individual company, firm, corporation shall participate in the tender process unless it obtained or possess valid Agent License under OMV (licensing Agent) Rules 2014.
3. The tenderer should have minimum two trucks standing in his own name and 3 No. of mini trucks on lease basis list such trucks along with up-to-date documents (Attested Xerox copy).
4. The successful tenderer shall be required to lift Wheat from F.C.I Depots of Bolangir District and Rice from OSWC/CWC Godown, of Bolangir District and transport the same to different WSHGs/ Anganwadi Centre points respectively as per the direction of the Collector/DSWO, Bolangir within the specified period. After lifting the wheat from F.C.I Depot and rice from OSWC godown, the wheat /rice will be delivered at the WSHG points/Anganwadi Centres on the same day without any storage during transit.
5. It is responsibility of the transporting agent to lift the rice from OSWC Godown on proper weighment and deliver the same to the AWWs on proper weighment in the presence of the member of the Jaanch/Mother Committee and in no case short supply or delivery shall be made by the agent to the AWWs. The weighment machine to be carried by the transporting agent must be sealed and stamped by the inspector of the Legal Metrology, Bolangir. The agent will be held responsible to taking delivery of the stock, shortage and damage noticed if any during transit and no shortage will be allowed to the agent. The quality and quantity of the foodstuff being transported may be inspected by the Government Official authorized by the Collector during transit and also at the delivery point. There shall not be any change both in quality and quantity of the food grains during transportation by the transporting agent and for any shortcoming in this front the transporting agent. If any misappropriations is noticed during inspection or otherwise a penalty shall be levied which would be equivalent to 10 times of the cost of misappropriated food grains apart from initiating criminal cases.
6. The successful tenderer shall submit Bank Gurantee / TDR of Rs.2000000/- (Twenty Lakh) from a Nationalised/Scheduled Private bank within 7 days of intimation of acceptance of his tender.
7. The tenderer should submit the following documents along with the tender paper. In absence of any documents /paper in the tender form will be liable for rejection by the competent authority. The tenderer shall have to produce the original document if necessary before the Tender Committee for verifications.
 - i) Original tender paper duly signed by the tenderer as token of acceptance of the terms and conditions of the tender.

- ii) Attested copy of the Valid Agent License owned by the tenderer under Orissa Motor Vehicle (Licensing Agent) Rules,2014 for Bolangir district.
 - iii) Attested copy of the valid Income Tax/ Pan Card last three year IT Return.
 - iv) Certificate of past experience at least Two year form the District Collector/ any Government Organization in handling / Storage transport work to be furnished along with the tender paper The accepting authority shall have the right not to accept tender of registered firm/ authorized licensing. Transport Contractors / Agents who have not performed satisfactorily in the pending year under the Government of Odisha.
 - (v) EMD to the sum of Rs.10,00,000 (Rupees Ten lakh) only in shape of NSC/Term Deposit/ FD etc duly pledged in favour of District Social Welfare Officer, Bolangir shall be furnished along with *tender*. Tenders without Earnest Money will be liable for rejection, Cash / Cheque and Bank Draft shall not accepted .No request for transfer or any previous deposit on adjustment of earnest money for any claim payable will be entertained. Any deviation to the above stipulation will entail complete rejections of the tender paper. No tenderer shall be allowed to withdraw his tender Earnest Money Deposit until the tender is finalized. In case the successful tenderer refused to be Transporting Agent *after* acceptance of his tender. the Earnest Money Deposited by him will be liable for forfeit.
 - (vi) The EMD of the unsuccessful tenderer shall be refundable after finalization of the tender. whereas the EMD of the successful tenderer will be kept as a security deposit and will be released after the successful completion of the contract period. Settlement of payment thereof and audit of such account and after obtaining the audit report. The Collector/ DSWO, Bolangir is not liable for payment of any interest of security deposit or any depreciation thereof. The branch of any terms and conditions as per agreement and failure/unwillingness to undertake transportation work by the selected tenderer within the time limit after acceptance his tender may lead to forfeiture of EMD .The selected transporting agent will be blacklisted for any other Government Tender, if he fails to perform the duties as per agreement timely, regular supply for food grains on proper weightment.
 - (vii) The tenderer should file an affidavit either from the Executive Magistrate or from the Notary in support of that he/ she have no criminal background.
7. The successful tenderer shall have to enter into registered agreement with Collector. Bolangir as per the terms and conditions mentioned in the specified agreement format within 7 days of intimation of acceptance of his tender.

11. In case of violation of the condition of Tender the Agent will be booked under IPC, Essential Commodities Act., and Prevention of Food Adulteration Act. and Prevention of Black Marketing Act.
12. The right of acceptance of tender rests with Collector, Bolangir who does not bind himself to accept the lowest tender and also reserves the right to cancel or reject any or all the tender without assigning any reason thereof. In case of any dispute the order/decision of the Collector, Bolangir will be final and binding.

The CDPO will furnish consolidated report/statement on total quantity of rice stock received in a particular month which should be enclosed by the transporter along with claim bill and submit in the Office of the DSWO, Bolangir. The DSWO have the right to deduct and adjust any amount found recoverable towards loss or damage of the rice.
3. The Collector, Bolangir may terminate the contract for violation of terms and conditions of the Agreement.
4. The payment shall be made as per approval rate incorporated in the agreement.
5. No request for enhancement of the approved rate shall be entertained during the terms and agreement /Contract.
6. The successful Agent should carry weighing scale and its devices in his cargo and give delivery of foodstuff the Anganwadi Centre Points on proper weightment in presence of AWW / Scrutiny Committee / Mothers Committee members. Delivery of stock intermediate point is not allowed.
