



## **ODISHA ADARSHA VIDYALAYA SANGATHAN**



### **BACK GROUND**

Odisha Adarsha Vidyalaya Sangathan is a path breaking initiative of Govt. of Odisha to provide quality teaching in English medium at Secondary & Senior Secondary level for the children specially in semi- urban or rural areas and to give scope to rural talents who are unable to afford English medium education. Originally, a new scheme "Model Schools" was launched by Govt. of India under central assistance scheme to provide a good quality English Medium scheme as par with Kendriya Vidyalaya in all Educationally Backward Blocks of the state. Subsequently, the scheme has been delinked from central assistance from the financial year 2015 -16. After de-linking of the scheme, State Govt. has decided to implement the scheme and establish one Odisha Adarsha Vidyalaya in all 314 blocks of the state phase wise and one Iconic OAV at Andharua, Bhubaneswar. At present 249 OAVs are having class XI (Science) and 33 OAVs class XI (Commerce). OAV, Tentulikhunti, Gudvela, Balangir has Science stream which has been opened from the current academic session 2025-26.

Basically, Adarsha Vidyalayas will have infrastructure and facilities of the same standard in Kendriya Vidyalaya with stipulation on Pupil-Teacher ratio, ICT usages, holistic educational environment, appropriate curriculum and emphasis on output and outcome. The objective is to provide high quality English medium school to the rural as well as semi-urban talents.

### **Key features of Odisha Adarsha Vidyalayas:**

- The objective is to provide high quality English medium school to the rural as well as semi-urban talents.
- Vidyalaya will have holistic and integral touching upon physical, aesthetic development in addition to academic.
- The Vidyalaya will have adequate ICT infrastructure and internet connectivity.
- There will be sufficient scope for sports and co-curricular activities.
- There is provision of Art, Music and Computer Teacher besides subject teachers.
- Special emphasis will be given on teaching of Science, Math and English.
- There is provision of well-equipped laboratories and library.
- Medium of instruction is English and the Vidyalaya is affiliated to CBSE, Delhi.
- The Vidyalaya will have appropriate pace setting activities so that Vidyalaya in the neighborhood can benefit from it.
- The classes will be from VI to XII having two (02) sections in each class with intake capacity of 40 in each section.
- All efforts will be made to make it really a centre of excellence.

### **Curriculum for Senior School Certificate Examination (Science Stream)**

#### **(A) Scholastic Areas:**

1. The Science Stream of the Vidyalaya will have **80** seats having **two sections**.
2. The Subject combination for **Science Stream** is as follows:

#### **MAIN SUBJECTS:**

- I. **English Core (301)**
- II. **Physics (042)**
- III. **Chemistry (043)**
- IV. **Mathematics (041)**
- V. **Biology (044)**

### OPTIONAL SUBJECTS:

- I. **Painting (049)**
  - II. **Physical Education (048)**
  - III. **Information Technology (802)**
3. All notifications and circulars issued by **CBSE** shall be followed for **subject combination** in Class XI as per stipulated Guidelines
  4. Each subject carries **100** marks.
  5. **Physics, Chemistry, Biology & Physical Education** subjects have practical of **30** marks and theory of **70** marks
  6. In **English, Mathematics**, there will be **20** marks for Internal Assessment and **80** marks for pen & paper test.
  7. Subject **Painting (049)** will have **30** marks Theory and **70** marks Practical. Similarly subject **Information Technology (802)** will have **60** marks theory and **40** marks practical.
  8. In **Mathematics** the students have to do 10 activities in a year as per the list and guidelines provided by NCERT Laboratory Manual. Accordingly, internal marks will be awarded as per their activities performed.
  9. In **English** the Internal Assessment (20 marks) will be totally based on Assessment of Listening and Speaking skills.

### **(B) Co-Scholastic Areas:**

The Co-Scholastic activities used for both cognitive and non-cognitive development of students can take place by exploring the child to the lesson on scholastic subjects and co-scholastic subjects. Each student has to keep following the co-scholastic subjects,

- I. **General studies.**
- II. **Health & Physical Education.**
- III. **Work Experience.**

There will be allotment of 2 periods per week to each co-scholastic area and assessment will be through grades (A1, A2, B1, B2, C1, C2, D1, D2 and E).

### Admission Guidelines:

#### ❖ **MINIMUM ELIGIBILITY:**

- I. A student belonging to the General/OBC/SEBC must have secured 55% or above marks in aggregate along with minimum

- 50% marks in both Mathematics and Science (combined) in Class X board examination.
- II. A student belonging to the SC/ST category must have secured 50% or above marks in aggregate along with minimum 45% marks in both Mathematics and Science (combined) in Class X board examination.
- III. All the Students who have passed in CBSE and other Boards Class-X Examination with Mathematics (standard) or Mathematics (Basic) subject are eligible for apply.

❖ **ORDER OF PREFERENCE FOR ADMISSION:**

- a. Students of own OAV (Including students selected for Iconic OAV)
- b. Students of other OAVs (of same district, not having Class XI selected for Iconic OAV)
- c. Students of other OAVs (of same district, not having Class XI)
- d. Students of other OAVs (of same district, having Class XI)
- e. OAV students of other districts
- f. Students of Government/ Government aided High schools within the same block.
- g. Students of private high schools within the same block.
- h. Students of Government/ Government aided high schools of other blocks of the district.
- i. Students of Private high schools of other blocks of the district.
- j. Students of Government/ Government aided High schools of other district.
- k. Students of private high schools of other district.
- l. Students of other states

❖ Student selected for Iconic OAV, Bhubaneswar is eligible for taking admission in Science stream only.

❖ Merit list shall be prepared on the basis of merit i.e. the marks secured in Class X board examination (CBSE or any other board).
