CORRIGENDUM

1. Bid Document Cost – Page No. 4 & 27 – Bid Document Cost here by change to - "BID Document Cost Exemption is allowed to the bidders as per Govt. Guideline".
2. Period of Contract – page No 4 & 26 – Period of Contract hereby change to – The total contract period shall be **three (3) years**. However, the initial agreement will be for a period of **three (3) months**. Upon satisfactory performance during this initial period, the undersigned reserves the right to extend the contract for an additional **one (1) year**. After completion of this one-year extension, the competent authority shall review the agency's performance and may further extend the contract for a period of **one (1) or two (2) years**, as deemed appropriate based on the performance.
3. Clause 6.2 a Page No. 20 – "Potential bidders may apply for both zones and may also be awarded contracts for both zones, subject to fulfilling all eligibility criteria and based on the evaluation of their proposals."
