**EXPRESSION OF INTEREST (EOI)**

Expression of interest (EOI) is invited by the Chief District Agriculture Officer, Balangir from intending Farmer Producer Organization (FPO), Co-operative, or Public/Private Corporation operating in the Oilseed sector to engage as Value Chain Partner (VCP) for seed distribution/ Conducting Farmer training & Field Schools with help of Technical Support Agencies (TSAs)/Farmers training ,etc. The eligibility criteria for the Value chain partner (VCP) are mentioned below. The organization should be preferably from Balangir district with a specific focus on working for Patnagarhand Sainitala block & should submit the EOI documents in sealed cover super scribed as "Application for Value Chain Partner for "National Mission on Edible Oil-Oil Seed" to the O/o the Chief District Agriculture Officer, Balangir on or before 27.09.2025, 10.30 P.M . and it will be opened on the date recommended by DEC members and in presenct of them. The organizations may also submit their EOI through post/couriers or in person at the office of the undersigned during the working hours. The CDAO, Balangir will not be liable for any delay or not offering the EOI in the stipulated date & time mentioned above.

**Condition**

- The authority reserves the right to accept or reject any or all EOI without assigning reasons thereof.

**Eligibility Criteria for FPOs/ Cooperatives:**

- Should be registered under the Companies Act or Cooperative Act.
- Should have an experience of at least 3 years working in the district where the cluster is formed.
- At least 200 farmers should be registered in the FPO or Cooperative.
- Average annual turnover in the past 3 years should be greater than 9 lakhs.
- Equity of at least Rs. 3 lakhs by the farmers in the FPO. Recipients of any Equity Grant by the Government shall be given preference.

**Eligibility Criteria for Public or Private Corporations:**

- Centre or State Public sector undertaking working in the seeds, edible oil, fertilizer sector, and private corporations registered with the Solvent Extractors Association of India (SEA), the Soybean Processors Association of India (SOPA), Mustard Oil Producers Association of India (MOPA), Indian Vegetable Oil Producers' Association (IVPA), National seed Association of India (NSAI), Federation of seed Industry of India (FSII) shall be considered for forming VCPs.
- Public or Pvt. Corporations fulfilling the following criteria shall be selected based on the performance matrix.
  - ❖ Minimum annual turnover of Rs. 10 crores.
  - ❖ No defaults of taxes in last 3 years.
  - ❖ Working as a producer of seeds, fertilizer, and edible oil for at least the last 5 year.
