

The quotation completed in all respect will be received **from 30.10.2025 to 15.11.2025** during office hour in Zilla Parishad, Balangir through Speed / Registered posts & Courier only and will be opened on 17.11.2025 at 11.00 AM in presence of the committee members and bidders or their authorized representatives in the office chamber of the CDO-cum-EO, ZP, Balangir. The authority reserves the right to accept or reject any or all partially or in full the bids without assigning any reason thereof.

Terms & Conditions

1. Bidders are required to submit the technical and financial bids separately. The bids in sealed Cover-I containing "Technical Bid" and sealed Cover-II containing "Financial Bid" should be placed in third sealed cover super-scribed "Bid for supply **Poshan Sakhi Kit for FNHW** under OLM" Balangir must reach the undersigned on or before 15.11.2025 at 5.30 PM by **Speed Post/ Regd. Post & Courier** only.
2. The bidders must be a reputed printing firm / company.
3. The bidder can submit only one bid. Multiple bids submitted by any bidder may result in rejection of all his bids.
4. The Bidder must have registered under Goods & Services Tax (GST) and must have a valid GSTIN number.
5. The bidders have to submit their PAN details along with Bid document (Copy to be attached).
6. The bidders should have registered his firm under GSTIN No. The bidders must be submitted the GST registration Certificate & copy of GSTR-3B return (July, 2025) documents as proof along with the tender paper. The bidders must be submitted IT return filing documents for last 3 years along-with the tender paper that is Financial Year 2022-2023, 2023-2024 & 2024-2025.
7. The bidders selected have to supply the items within 10 days from the date of issuance of work order.
8. No part of the contract will be sub-let without the prior written permission of the authority.

9. Quotation shall remain valid for a period not less than 90 days after the deadline date specified for submission.
10. The Purchaser will evaluate and compare the quotations determined to be substantially responsive.
11. The Purchaser will award the contract to the bidder whose quotation has been determined to be substantially responsive and who has offered the lowest evaluated quotation price.
12. The bidder whose bid is accepted will be notified of the award of contract by the Purchaser prior to expiration of the quotation validity period. The terms of the accepted offer shall be incorporated in the purchase order.
13. Payment shall be made after delivery of the goods through E-Transfer to the bidder account after submission of the bills and vouchers and successful deliver at OLM Cell, Zilla Parishad, Balangir.
14. Any effort by a bidder to influence the purchaser in its decision on bid evaluation or placement of purchase order may result in rejection of the bidder's offer.
15. The price quoted should inclusive of cost of material to be supplied, all taxes & charges, packing & transportation cost to deliver at OLM, Cell, Zilla Parishad, Balangir.
16. The bidder must submit a sample Intergenerational cycle in flex & One flex covering 16 picture cards as per specification during the opening of the tender document.
17. Any legal dispute arising out of this is subject to Balangir jurisdiction only.
18. Notwithstanding the above, the CDO-cum-DMC, OLM,ZP, Balangir reserves the right to accept or reject any or all bids at any time prior to the issue of contract letter.
19. The bidders may be present in person or through one of their representative(s) during the opening of quotations as per the date and time fixed by the CDO-cum-DMC, OLM,ZP, Balangir.
20. The bidder has to deposit a earnest money deposit (EMD) of Rs.25,000/- (Rupees twenty five thousand) only in the form of FD/TD/KVP should be pledged in favour of **C.D.O-cum-District Mission Coordinator, OLM, Balangir**. Photo/ Fax copies of the FD/TD/KVP will not be accepted. The earnest money of unsuccessful bidders will be returned to them without any interest within thirty (30) days after awarding the contract and on receipt of written request from the Bidders. The earnest money of successful bidder will be returned only after Successful completion of work.
21. The successful bidder of the contract will have to deposit a Performance Security of Bank Guarantee drawn in favour of "**C.D.O-cum-District Mission Coordinator, OLM, Balangir**". Performance Security of 5% of the total contract value in the form payable at Balangir same date of receiving the order. Performance security should remain valid for a period of sixty days beyond the date of completion of all contract obligations of the supplier. If the successful bidder fails to submit the Performance Security within the time, EMD will be forfeited and the order will be rejected. Order will be taken to award the contract to the L2 bidder as per price quoted by L1 bidder. Performance Security will be forfeited in

the event of breach of contract obligations by the Supplier. The Performance Security will be returned to the bidder after successful completion of the programme.

22. The 2nd lowest bidder will be offered for supply if the 1st Lowest Bidder fails to do show which will impose penalty followed by forfeiting the EMD submitted.
23. The bidders have to supply the items as per the price quoted without any condition, else the bid will be rejected and the EMD will be forfeited.
24. The authority if required can send the samples to the EPM laboratory for testing further random items from the consignment supplied by the successful bidder after issuance of work order can also be cross checked with the samples at EPM laboratory.
