The Divisional Forest Officer, Titilagarh (KL) Division on behalf of Governor of Odisha invites Percentage Rate Bid in **Double Cover System** in online mode for the construction building works as detailed in the table below from eligible contractor as mentioned in Column 6 registered with the Statement Government and contractors of equivalent Grade/ Class registered with Central Government/ MES/ Railways for execution of Composite Building Works. The proof of registration from the appropriate authority shall be enclosed along with the Bid. The successful bidder who has not registered under State Government has to register under the State PWD in appropriate class of eligibility before signing of the agreement.



2. The bidder shall furnish bid security as specified for the work in the table Col. No. 4 above as part of its bid through in shape of N.S.C/ Post Office Saving Bank Account/ Post Office Time Deposit Account/ Kisan Vikas Patra/ bank Guarantee in favour of Divisional Forest Officer, Titilagarh Kendu Leaf Division from any Nationalized Scheduled Bank in India counter guaranteed by its local Branch at Bhubaneswar/e-Bank Guarantee executed on the National e-Governance Service Limited (NeSL) Digital Document Execution Portal towards E.M.D/ initial Security Deposit/ any other security deposit from the contractor or supplier as per Office Memorandum No. 075546000320322-1499/W dated 01.02.2023 of Govt. of Odisha, Works Department.
3. The bidder shall have to transfer the cost of tender paper "ONLINE" for the amount as specified for the work in the Table Col. No. 5 above as part of bidding through a process as mentioned in the DTCN.
4. The bidder shall have to upload the bid security declaration as specified for the work in the Table Col. No. 4 above as part of bidding through a process as mentioned in the DTCN.
5. The Bid Documents will be available in the **website: - [www.tenderodisha.gov.in](http://www.tenderodisha.gov.in)** from **03.12.2025 to 17.12.2025 up to 5.00 PM** for online bidding.
6. The bidders must possess compatible Digital Signature Certificate (DSC) of Class - II or Class — III.
7. Bids shall be received on "ONLINE" **on or before 5.00 PM of 17.12.2025.**
8. Bids received online shall be opened at **11.30 AM on 18.12.2025** in the office of the undersigned in the presence of the bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC, if the office happens to be closed on the last date of opening of the bids as specified the bids will be opened on the next working day at the same time and venue.


9. In case the bidder intended to quote less price than the amount put to tender shall be abide by the Government Order No. 4559 Dt. 05.04.2021 i.e. amendment to Para - 3.5 (v) of OPWD Code, Vol.-I with modification that "Additional Performance Security" shall be deposited within 7 (Seven) days of the issue of the "Letter of Acceptance" by failing which the bid shall be cancelled and the security deposit shall be forfeited. Further, proceeding for blacklisting shall be initiated against the bidder.
10. Bidders are to submit only the original BOQ uploaded by publisher after entering relevant fields without any alteration/ deletion/ modification. Multiple BOQ lead to cancellation of bid.
11. As it is a percentage rate tender, the bidders quoting zero value is valid and will be taken as schedule of rates.
12. The authority will not be held responsible for any technical snag or network failure during online bidding.
13. Other detail can be seen in the bidding documents.
14. The authority reserves the right to cancel any or all the bids without assigning any reason thereof.
15. The Addendum/ Corrigendum if any will be hoisted in the website only.
16. The intending bidders are required to furnish their email address and cell phone numbers to inform them any message relating to the tender.
17. Engineering contractors who are desirous to avail the facility of exemption of EMD/ISD are required to submit the scan copy of affidavit along with bid document to the effect that he/she had not yet availed the facility during the current financial year as per codal Provision.
18. The SC/ST contractors willing to avail the facilities as fixed by the Government will submit scan copy of affidavit for the same along with tender documents; otherwise, they will not be entitled to avail such facilities.
19. Additional performance security shall be submitted by the successful bidders when the bid amount is less than the estimated cost put to tender as per DTCN clauses.
